That the purchase of the Hazmat equipment at a total cost of \$30,240 (including HST) be APPROVED. It will be funded as follows: \$16,632 from JEPP funding, \$13,608 from the Ontario Fire Service Grant Reserve Account 1768, which has a balance of \$138,877, as of March 31, 2012.

That the CAO and the Chief Financial Officer/City Treasurer and Corporate Leader Finance and Technology be authorized to sign the JEPP Application Funding Approval Form and the related Claim form, which agreement shall be satisfactory as to form to the City Solicitor and Corporate Leader Economic Development and Public Safety, and as to technical content to the Fire Chief.

2. BACKGROUND:

Windsor Fire & Rescue Services applied to the Joint Emergency Planning Program for funding to support the purchase of Hazmat equipment. We subsequently received notification from the Ministry that the request was approved, based upon the funding formula of 45% provincial/municipal and 55% federal. All funds are paid after the project completion.

3. DISCUSSION:

We requested to purchase a Rescom modular hard-line communications system. This system is the state of the art, intrinsically safe, NFPA and OSHA compliant. No radios are required, which frees the hands of the rescuer in the confined space. A communications and safety line is combined in one rope to reduce entanglement. Coloured ropes easily identify and designate the primary and secondary rescuers in the confined space. The system provides over 240 hours of battery life, and can be used in other applications such as rope rescue and ice rescue.

We also requested to purchase a Drager Colt Pak. The colt pak will allow us to complete a full system for Confined Space Entry and Rescue. These units are required for the supplied air system that will be used in the confined space system. SCBA cannot be used, due to tight spaces; the rescuers require a hose line due to limited space to manoeuvre. They system is light, enables egress in tight spaces. The Colt Pak provides a bailout system in case the hose line was pinched, or severed. This provides a safety backup system in place.

This equipment is more technically advanced and is more in line with other level 3 teams in Ontario.

It should be noted that this will be the last year that the JEPP funding will be available. We have received notification that the program will end after the 2012/2013 projects are completed.

4. RISK ANALYSIS:

We are required to have the application funding approval formed signed by May 30, 2011. This is the last year that JEPP funding will be available as we have been advised that Federal contributions for emergency preparedness projects under JEPP will end in 2013. Funding continues to be in place for projects submitted for consideration in 2012-13.

5. FINANCIAL MATTERS:

As stated, the funding formula is 45% provincial/municipal and 55% federal.

The purchase of Hazmat equipment at a total cost of \$30,240 (including HST) will be funded as follows: \$16,632 from JEPP funding, \$13,608 from the Ontario Fire Service Grant Reserve Account 1768, which has a balance of \$138,877, as of March 31, 2012.

There is sufficient funding in the Ontario Fire Service Grant Reserve Account 1768 to fund the purchase of \$13,204 (including HST) for Hazmat Equipment and it also meets the criteria set out in the grant.

As you know, EMO is administering the JEPP program on behalf of the federal government. Due to the excessive funds left unused every year and the long list of projects waiting for funding; there is now a requirement to submit a mandatory status update report of your project(s) to EMO by September 30, 2012, which can be done by simply sending an email to kay.agelakos@ontario.ca. If the report is not received by that date, EMO may retract the funding and reallocate the funds to projects on the wait list.

Your project must be completed in accordance with your project application and the approved funding items listed on line (in some cases the funding items may have changed and/or deleted since the original application). A request for modifications to your project can be made at any stage during the project year. A formal written request to EMO is required to make any modifications to an approved application. Before making any purchases, you must receive official notification from EMO advising that the modifications have been approved. These changes may impact the federal funding share. Once a claim is submitted it is assessed against the most up-to-date approved project data.

You are reminded that your project must be completed during the current fiscal year. When your project is finished, please complete the JEPP claim form along with your receipts, proof of payment and a media acknowledgment or some other public acknowledgement of the funding assistance provided by the federal government, and forward it to EMO for reimbursement of the federal share of your project. The date for submission of the claim is March 31, 2013.
