RE: Provincial/Division Corridor Improvements Phase 2 to 4 – Provincial Road from south of Cabana Road East to Walker Road – Project Status

The City of Windsor has retained Dillon Consulting for the design of Provincial/Division Corridor Improvements Phase 2 to 4. The consulting services include the Provincial Road widening design & engineering between south of Cabana and Walker Road, the coordination with the utility agents for the corridor utility relocation work and the coordination with property owners for the EA recommended land & easement acquisition plan subject to Council approval.

The purpose of this letter is to provide you with updated information regarding the project status and utility relocation timelines.

The utility agents will commence their relocation work in the 2019 and the following year(s). Tentatively scheduled, the gas main relocation work will be implemented by the Enbridge Gas (formerly Union Gas) starting in the week of April 23, 2019. Aecon is the contractor for the gas main relocation work.

Please be advised that for those properties that have fences, planters, curbs & boulders, decorative lights and any other structures that currently encroaching onto public Right-of-Way, we urge you to remove all the encroachment prior to the commencement of the utility construction if you would like to salvage them. As per City of Windsor Bylaw 25-2010, we would not allow any existing encroachment that without City of Windsor's encroachment agreement or permit after the completion of the road work. If you currently have an encroachment agreement, we will re-install them after the completion of the work. However, we are not going to re-install any encroachment that currently without the agreement or permit.
