Mr. Colucci advises that there was general consensus amongst the BIA's related to the governance by-law that was created and concludes by requesting that Council adopt the BIA Governance By-law and schedules document as part of the administrative report.

Councillor Jo-Anne Gignac inquires about the holding of land provision. Ms. Askin Hager provides information related to the *Municipal Act* and the requirements.

7. REGULAR BUSINESS ITEMS

7.1 Governance Bylaw for Windsor Business Improvement Areas – City Wide

Debi Croucher, Executive Director, Downtown Windsor BIA

Debi Croucher, Executive Director, Downtown Windsor BIA appears before Council sitting as the BIA Board of Directors regarding “Governance Bylaw for Windsor Business Improvement Areas” and requests that the City reconsider their position of possibly withholding payment to the respective BIA’s until compliance with financial accountability requirements are met. Ms. Croucher adds that she has reviewed of the provisions of the *Municipal Act*, and questions the discipline measures related to this. Ms. Croucher also requests that the City takes over the election and audit functions of the BIA as well as implementing a transition period whereby the City would retain financial oversight for a period of 3-4 weeks prior to elections to ensure that the BIA Board of Directors are approved by Council, in place and that the BIA Boards have a meeting to ensure daily operations of each BIA can be maintained without delay.

Kaitlyn Karns, Executive Director, Ford City BIA

Kaitlyn Karns, Executive Director, Ford City BIA appears before Council sitting as the BIA Board of Directors regarding “Governance Bylaw for Windsor Business Improvement Areas” and expresses concern with Schedule C—section 3 of the proposed BIA Governance by-law related to the reserve fund requirements and would like Council to reconsider this clause to allow for all current monies to be retained without a plan, but moving forward that any new monies would require a plan, in accordance with the new by-law. Ms. Karns doesn’t want to see funds spent, just to spend them if there is no plan and requests that the status quo continue with the current level of reserves.

Sonia Klinger, Olde Sandwich Towne BIA

Sonia Klinger, Olde Sandwich Towne BIA, appears before Council sitting as the BIA Board of Directors via video conference regarding "Governance Bylaw for Windsor Business Improvement Areas" and is available for questions.

Councillor Kieran McKenzie inquires about the withholding of levies and whether there is another tool that can be used to gain compliance. Ms. Croucher indicates that the City could conduct annual audits of all BIA's which would ensure financial compliance.

Councillor Kieran McKenzie requests clarification related to the interim period of the outgoing board, until new board is set up. Ms. Croucher provides details related to her request.

Councillor Jim Morrison requests clarification of Ms. Karns related to the reserves. Ms. Karns indicates that if the status quo was maintained until the end of 2023 it would still be difficult for them to provide a plan for all the unallocated funds. Ms. Karns adds they would like to keep the funds unallocated for next year should the need arise, and would rather not spend the money just to abide by the by-law, but would rather have the money in case issues arise.

Mr. Colucci clarifies the budget implications and indicates that Council approves the BIA budgets and has the ultimate authority. Mr. Colucci adds that they are asking the BIA's to indicate what the monies are being allocated for, it could be a long term plan as long as they are providing the information to the City.

Councillor Kieran McKenzie inquires as to the proposal to withhold the levies and whether there are alternative measures that can be put in place to gain compliance. Ms. Askin Hager (City Solicitor) indicates that most of the requirements are financial and the City has the right to require it. Mr. Mancina adds that it all revolves around the budget, templates are being provided, to ensure compliance in order to support their budget, the submissions are essential to maintain oversight.

Councillor Kieran McKenzie inquires about the section related to standards of employee deportment. Ms. Askin Hager indicates that the BIA themselves would bring the request to remove someone if their is a significant issue although Council always retains the right to remove a member.

Councillor Kieran McKenzie inquires whether there is an opportunity for Council to initiate that process or if it is through the BIA. Ms. Askin Hager indicates that Council, at any time, can remove directors, although the BIA should address the issue internally first.

Councillor Fabio Costante inquires about the reserve funds and requests clarification related to the new process. Ms. Guthrie (Deputy Treasurer) provides a Reserve Fund process outline and information related to the past when general reserve balances were growing. Ms. Guthrie indicates that it would be prudent to establish these parameters and develop a plan. Ms. Guthrie adds that timelines are not stipulated for executing the plan, it could be long term, it just has to be reported

that way. Administration had determined that monies were being spent on items that weren't included in the budget, the new process would ensure accountability.

Councillor Fabio Costante inquires about the reporting structure to Council. Ms. Guthrie indicates that an annual report from the BIA would accompany the audited financial statements, outcomes of the current year, and a plan as a result of that, in addition to the annual budget submission.

Councillor Fabio Costante inquires about hiring employees and whether that applies to contractors. Ms. Askin Hager indicates that this would not apply to contractors but strictly employees of the BIA. Ms. Askin Hager adds that this requirement is prescribed in the *Municipal Act*, and suggests perhaps collaboration with the Windsor Business Improvement Area Advisory Committee which would benefit all BIA's.

Councillor Fred Francis inquires about the reserve funds and whether there is an option to give the money back to the membership if it remains unallocated. Mr. Mancina (City Treasurer) indicates that if there wasn't a spending plan adopted by the BIA, the levy could be reduced or the funds could be returned.

Councillor Ed Sleiman inquires about plans changing as different issues arise. Mr. Colucci indicates that the BIA should advise the City of the new plan.

Councillor Kieran McKenzie inquires about the interim period post election. The Mayor indicates that the slate of BIA requests for appointments have been approved, and reminds Council of the 60 day plan and to return oversight to the respective BIA's.

Councillor Kieran McKenzie inquires about the period after the Municipal Election and prior to the BIA elections when the existing BIA Board stays in power until Council approves the new board, can Council take on the role for a small period of time. Mr. Colucci indicates that it would be at the discretion of Council, although, if adopted the Governance By-law and Schedules would be in place outlining all the processes, which would guide the Boards.
