***Item No. 11.3 "Agreement Amendment for RFP 21-20 for the Municipal Class Environmental Assessment for Ojibway Parkway Wildlife Overpass - Ward 1", for the Tuesday October 11, 2022 meeting of Windsor City Council.***

I would like to ***state my support for Item No. 11.3.*** As this item allows for existing Federal Government, Parks Canada Ojibway National Urban Park study Federal money to be directed towards completing a more detailed research study for a proposed extension of the Ojibway Parkway Wildlife Crossing - to extend further across the ETR Railyard.

This extension of the Ojibway Parkway Wildlife Overpass Crossing is what the Public has emphatically spoken for in the last few years. I began the public awareness campaign to deficiencies in the original design proposed for new 'Ojibway Parkway Wildlife Crossing' - as it first stood to cross over only the Ojibway Parkway, dumping wildlife onto the busy ETR Railyard. As we all know, the existing automobile crossing over the Ojibway Parkway connecting the Herb Gray Parkway to the new Canadian Customs Plaza of the Gordie Howe International Bridge is still much longer and wider than the proposed Ojibway Parkway Wildlife Crossing and presently crosses over the ETR Rail line. Our rare, local wildlife and nationally recognized species deserve the same protection and added habitat biodiversity linkage advantage of a Wildlife Crossing that *extends over both the Ojibway Parkway and the ETR Rail Yard.*

The Federal Government's ongoing 'Ojibway National Urban Park' (OUNP) process (which the City of Windsor is a partner) and local Federal MP Brian Masse's Private Member's Bill relative to the creation of the new Ojibway National Urban Park have allowed this proposed Ojibway Parkway Wildlife Crossing (sponsored in part and initiated by WDBA / BNA Community Benefits Funds emanating from public input) to now see the Ojibway Wildlife Crossing potentially done right from the start. Saving more expensive future costs had it been extended separately in the future. It would be a disservice and embarrassment to the proposed Ojibway National Urban



Park to not consider a fully extended Ojibway Parkway Wildlife crossing over the ETR Rail yards as much as it would actually increase fence funnelled wildlife mortality onto the rail tracks if the Wildlife Crossing extension is not added. Let common sense prevail and thus allow for future wildlife enhancement and preservation of species. Move this forward now for both present and future generations.

Windsor-Essex already has the largest Wildlife Crossing in North America over the Herb Gray Parkway. That particular existing Wildlife Crossing over the Herb Gray Parkway already achieves great linkage at the eastern portion of the proposed new Ojibway National Urban Park. That Herb Gray Parkway Wildlife Crossing achievement was fought for by the general public and even lead by former Windsor Mayor Eddie Francis with the City of Windsor's then proposed 'Greenlink' proposal (this being the main element of Greenlink which was actually achieved). The Pedestrian / Cyclist Trails on the new Gordie Howe Bridge would not have occurred had the public not been involved and heard. The same with so many of the WDBA / BNA Community Benefits that emanate largely from the Windsor Essex Community Benefits Coalition Steering Committee. A Coalition of which I and numerous local residents, Bicycle Windsor Essex and various international Cyclist and Trail groups and many others participated in for so long.

A proper, extended Wildlife Crossing over the Ojibway Parkway (idea initiated at WDBA Citizen Focus Groups years ago in which I and many others participated) will serve to complete the linkage from Ojibway Nature Park to the Black Oaks Park to the soon to be officially added 'Ojibway Shores Park' and the Detroit Riverfront (thus comprising and linking a large portion of the proposed new Ojibway National Urban Park).

This is the time and opportunity to do things better. This amendment to the Municipal EA study allows for this and opens potential opportunity for additional new Federal funding to complete it. Any potential new assistive Federal Funding towards constructing the proposed Ojibway Parkway Wildlife Crossing's would not come to construct a truncated crossing version. That would be an embarrassment to Canada and Windsor and deter the intent and potential of the proposed new Ojibway National Urban Park. It is essential to see the job done properly and thoroughly from the start and consider the extended Ojibway Wildlife Crossing over the ETR Rail yard. It is also the Federal Government that regulates Canada's Railways and can serve to entice and insist that ETR comply as a willing partner. ETR should be proud to be a partner in such compelling and necessary endeavor as furthering the proper creation of an important element in a truly functional and great new Ojibway National Urban Park.

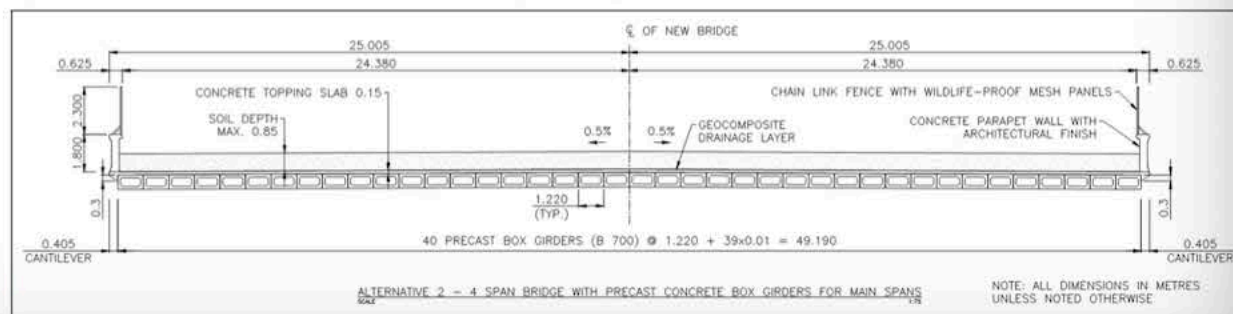


Figure 9-4: Conceptual Rendering for Wildlife Crossing Over ETR Tracks – Plan View

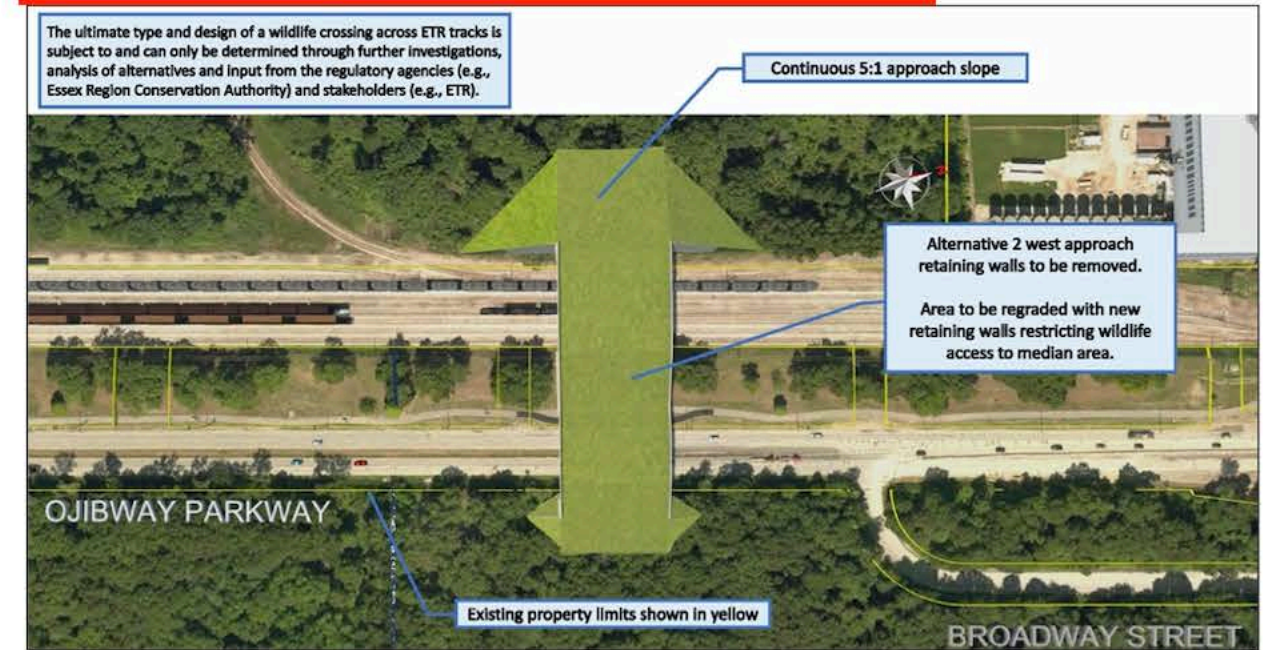
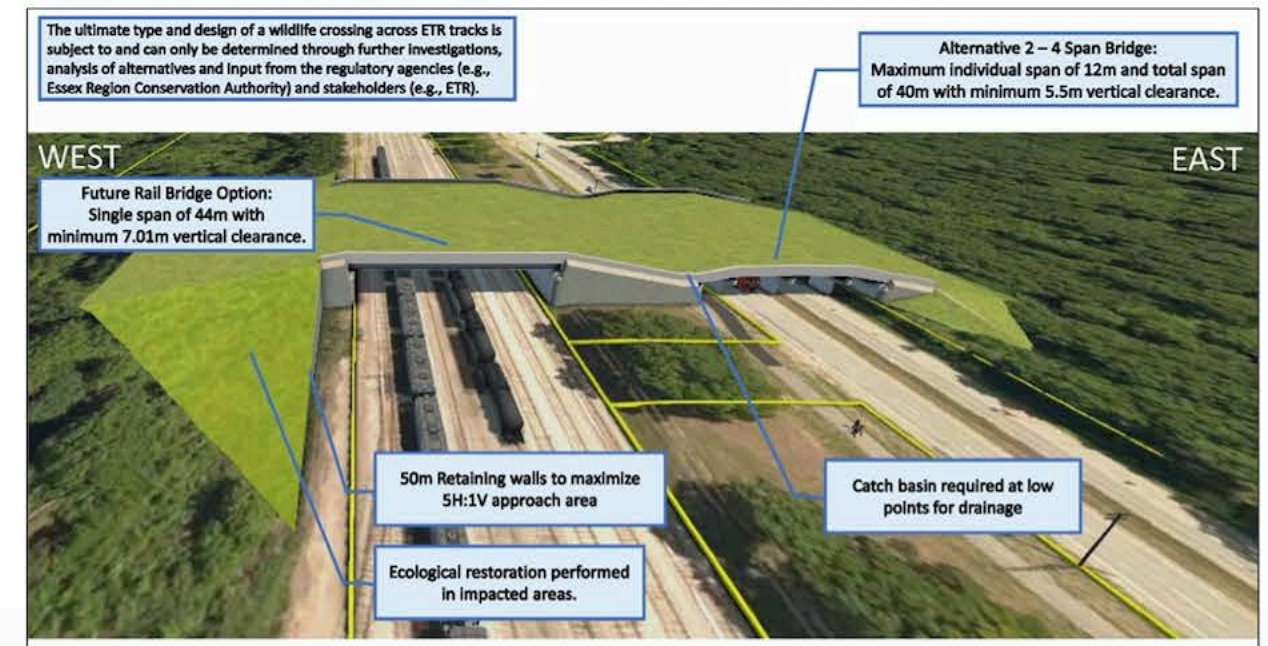


Figure 9-5: Conceptual Rendering for Wildlife Crossing Over ETR Tracks – Profile View
