# 3. DISCUSSION:

# !Legislative Assembly of Ontaria

Municipal Implications Overview of Bill 66, Restoring Ontario's Competitiveness Act, 2019 - Schedule 8-Ministry of Health and Long-Term Care amending subsection 44 (10) of the Long-Term Care Homes Act, 2007. (Copy attached as **Communication #2**)

#### !Ontario's Regulatory Regist61

The government is proposing amendments to Ontario Regulation 79/10 under the Long-Term Care Homes Act, 2007 relative to High Acuity Priority Access Beds. If approved, the proposed amendments would allow the designation of High Acuity Priority Access Beds in long-term care homes.

Applicants meeting the eligibility criteria would be placed on a separate waiting list for a High Acuity Priority Access Bed. Applicants to long-term care homes from Hospitals and the community, as well as existing long-term care home residents, would be eligible for placement in High Acuity Priority Access Beds. To be eligible for placement in these beds, applicants would require and likely benefit from the following:

- Ongoing nursing and other personal care given by, or under the supervision of, a registered nurse who has relevant expertise whether as a result of experience or training.
- Ongoing technology-based care that requires the support of a member of a college as defined under the Regulated Health Professions Act, 1991.

Applicants meeting the eligibility criteria for these beds would be prioritized under the Regulation similar to how applicants are currently prioritized for specialized units. High Acuity Priority Access Beds would be private accommodation, designated as basic accommodation, for the purpose of the co-payment rate and rate reduction.

It is proposed that residents of High Acuity Priority Access Beds undergo an interdisciplinary reassessment every three months, or sooner if there is a change in the resident's condition or circumstances. If the interdisciplinary reassessment indicates that the resident no longer requires and benefits from the care in a High Acuity Priority Access Bed, the long-term care home must discharge the resident, if the resident/caregiver has made alternative arrangements. Under the proposal, a licensee may transfer a resident from a High Acuity Priority Access Bed to another bed in the home.

The Ministry anticipates that the proposed amendments will have a minimum regulatory impact on long term care home operators. The Regulatory Impact Analysis includes start-up and ongoing annual training costs associated with supporting a broad range of complex care needs.

If regulatory amendments designating High Acuity Priority Access Beds are approved, long term care homes anticipate that additional provincial funding to support homes in enhancing their capacity to care for residents with complex care needs would be required to offset these additional costs. #### !Ministry of Health and Long-Term Care (MOHLTC)|

#### 1. Ministry Initiated Agreements

The 2019-2021 Long-Term Care Service Accountability Agreement (L-SAA) has been executed effective May 2019.

#### 2. Resident Quality Inspection-RQI 2019

The last Resident Quality Inspection was completed and reported in 2018.

#### 3. MOHLTC/Public Reports

On February 27, 2019, the MOHLTC submitted the Public Copy of Inspection Report No. 2019-791739-0003 following the Critical Incident System Inspection conducted on February 19, 20, 21 and 22<sup>nd</sup> 2019. Falls Prevention Inspection Protocols were reviewed during the course of the inspections and no issues were found. Non-Compliance Orders were not issued. (Attached as **Communication #4**)

# 4. Ontario Health Team

The Provincial government has recently proposed major changes to the way health care is delivered across Ontario. While the full implications of these announcements are not yet clear, the development of

Ontario Health Teams to manage service delivery is moving forward with specific deadlines for applications. As the City of Windsor provides direct health care through Huron Lodge Long-Term Care Home, and indirectly affects the well-being of residents through the provision of social services, it is imperative that Administration demonstrate collaboration and willingness to engage to support the government's vision for a fulsome and holistic continuum of care in Windsor and Essex County.

City Council approved Report No. C 78/2019 on May 6, 2019 (CR210/2019) endorsing a collaborative submission to the Ontario Health Team. (Copies attached as **Communication #5**)

# 5. Quality Improvement Plan and Mandatory Reporting Stats

Huron Lodge continues to use an interdisciplinary approach to ensure quality indicators are in line with the provincial averages.

Wound Care is slightly above average as it is dependent upon returns from Hospitals. Antipsychotic Use is reduced 10 points from 2018 to 1<sup>st</sup> Quarter 2019. Huron Lodge continues to work with the registered staff, physicians, pharmacist and the internal Behavioural Support Team to reduce usage of this medication in tandem with appropriate personalized interventions for the residents.

Health Quality Ontario, as the public reporting mechanism for Quality Improvement Initiatives for the health care sector, is the platform that the MOHLTC uses to monitor our performance and compare it with provincial averages. As such, Huron Lodge reviews and monitors all improvement programs on a continuous basis.

# !Commission on Accreditation of Rehabilitation Facilities {CARF} Accreditatio

The Huron Lodge Accreditation Anniversary Date is 6/30/2019. Staff continue to work on Accreditation standards and have returned the Annual Conformance to Quality Report for 2019. {Copy attached as **Communication #6**)

#### dvantAge Ontario/former Ontario Association of Non-Profit Homes and Services for Seniors (OANHSS)/

AdvantAge Ontario reviewed the 2019 Ontario Budget released on April 11, 2019. The organization welcomed the renewed commitment to add much-needed capacity in long-term, in-home, and community care.
