# 5. **BUSINESS ITEMS**

# 5.1 Proposal for Sculpture Project - "Black Day in July"

- C. Masterson reports the applicant has advised the "Black Day in July" bronze sculpture will not require any maintenance, however, C. Masterson states bronze sculptures require a great deal of maintenance.
- J. Butler expresses concern the general public will not be aware of the meaning of "Black Day in July" (Detroit 1967 riots) and questions if a plaque outlining the history is required.

The Chair asks if the sculpture is relevant to the City of Windsor as the riots occurred in the City of Detroit in 1967.

N. Pelkey states the issue is conflated and tangential as the artist is connecting the Detroit 1967 riots with Gordon Lightfoot as a means to push the project through. If this request had originated from a community group, the outcome may have been different.

Moved by N. Pelkey, seconded by Councillor Bortolin,

That the request by Timothy Schmalz, applicant to erect a bronze/granite sculpture entitled "Black Day in July" on the riverfront to showcase the Gordon Lightfoot song regarding the 1967 City of Detroit riots **BE DENIED.** 

Carried.

# 5.2 Proposal for Sculpture Project – "Mary Ann Shadd Cary"

C. Masterson indicates Donna Mayne, artist has received a grant for the first phase of this project. She adds Ms. Mayne is not requesting funding for the bronze sculpture of Mary Ann Shadd Cary.

Moved by N. Pelkey, seconded by Councillor Bortolin,

That the request by Donna Mayne, applicant and artist to create a life-size bronze sculpture of Mary Ann Shaad Cary at no cost to the City of Windsor **BE APPROVED IN PRINCIPLE** subject to the approval by the Social Development, Health and Culture Standing Committee and City Council, and if approved, that Administration **BE REQUESTED** to issue a Letter of Support

# 5.3 <u>Proposal for a Poster Size Plaque – "Project Bookmark Canada – Windsor Edition"</u>

C. Masterson states the Project Bookmark Canada – Windsor Edition is a national level project and she adds the applicant is not requesting funding. The applicant has suggested the former Holiday Inn site on the riverfront as the location for the plaque.

Moved by Councillor Bortolin, seconded by J. Butler,

That the request by Project Bookmark Canada to erect a poster size plaque that will celebrate Windsor's rich heritage as a literary landscape at a location to be determined by the Parks Department **BE APPROVED**.

# 5.4 Proposal for a Sculpture Project – "The Ford Auditorium Sculpture"

C. Masterson expresses concern that the artist has requested the Ford Auditorium Sculpture be placed directly across the river from its Detroit counterpart, which was installed near the abandoned train station. She suggests the sculpture could be placed in the Ford City neighbourhood and notes she will speak to the artist.

That the request of John Sauve, applicant to donate the Ford Auditorium Sculpture that reveals the historical relationship between the City of Windsor and the City of Detroit **BE APPROVED** subject to Administration working with the applicant to locate a suitable location for the sculpture.
