#### 4. Business Items

#### 4.1 Interview with the Mayor

The Chair advises that members of the Committee recently met with the Mayor and his comments relating to compensation and the tax free allowance were presented. It is noted a meeting with the one remaining Councillor not yet interviewed will occur in the near future.

#### 4.2 City of Windsor Policy for Elected Officials Claiming Travel Expenses

The City of Windsor Policy Travel and Business Expense Policy is discussed including travel and mileage reimbursement for members of Council.

- J. Mancina states it is common practice that no mileage be provided to Councillors for local travel.
- G. Wilkki indicates the Travel and Business Expense Policy, as presented, might not necessarily preclude that local mileage cannot be provided to Councillors.

The Chair suggests the Travel and Business Expense issue be included in the final report to City Council.

#### 4.3 Council Remuneration and Benefits 2018

The Presentation entitled "Council Remuneration and Benefits - 2018" is reviewed and it is generally agreed the document will serve as background information for the two upcoming Town Hall public meetings. Some edits to the Presentation include the following:

- Add actions taken to date including timelines:
  - o Interviews conducted with the Mayor and City Councillors
  - Windsor Council Compensation Review Survey undertaken to gather information regarding the public's opinion of remuneration for members of Council
  - o Conducting a survey of peer comparators regarding the 1/3 Tax Free Allowance (nine municipalities)
  - o Holding two Town Hall public meetings
- Suggestion to provide information relating to benefits for members of Council outlining an average cost to the City for a single person/family.

#### 4.4 Preliminary Results of the Windsor Council Compensation Review Survey

- J. Moore indicates over 600 responses to the Windsor Council Compensation Review Survey have been received to date. It is noted there will still be an opportunity for the public to participate in the survey following the two Town Hall meetings.
- D. Musyj suggests computers be available at the Town Hall meetings to allow an opportunity for the public to complete the Survey.
