#### 6. PRESENTATION

Wadah Al-Yassiri, City of Windsor Project Administrator is present to provide an update relating to the green features for the New City Hall. A document identifying the Sustainable Features, HVAC Systems, Efficient and Low Flow Fixtures/Appliances, Materials Free of Toxic Chemicals, Recycled and Regional Materials, Sustainable Landscaping, District Energy System, Bicycle Infrastructure, Stormwater Management, Green Roof and Sustainable Furniture is *attached* as Appendix "A".

W. Al-Yassiri states the following items were included in the "Base Bid" within the tender:

- 1. High Performance Envelope (Higher than Building code specification Insulations Levels, Optimization of Glazing Areas and Window specs)
- 2. Low Flow Water Fixtures
- 3. LED Lighting
- 4. Low VOC Materials
- 5. Recycling Content Materials
- 6. Regional Materials
- 7. Construction Waste Management
- 8. Storm Water Management for Building (Flow control roof drains)
- 9. Bicycle Infrastructure (Exterior bike racks included as part of the Civic Square Plaza)

- 10. Sustainable Landscaping (Native and adaptive plants within site limits, high efficiency irrigation)
- 11. District Energy (Heating and Cooling)
- 12. High Performance M & E

Provisional items included in the tender are as follows:

- 13. Daylighting (Daylighting Controls for shading devices and level of lighting levels)
- 14. Green Roof or White roof as an alternative
- 15. FSC, Low VOC and No Urea Formaldehyde added furniture systems
  - J. Passa indicates the louvers are not necessary on the north side of the building.

In response to a question asked by J. Passa regarding if an energy study has been conducted, W. Al-Yassiri responds a full study will be undertaken within a few months time.

D. Coronado questions the definition of "provisional" items. W. Al-Yassiri responds provisional items were added to the tender, however, if the cost to provide the provisional items is exorbitant, these items will be excluded from the project. D. Coronado indicates the "green roof" should not be a provisional item.

In response to question asked by J. Passa relating to the esplanade and the lack of a vertical statement, W. Al-Yassiri responds the vertical wall from the old City Hall will be incorporated into the new Civic Square (or part of it).
