4. BUSINESS ITEMS

4.1 Proposal for Funding from the Capital Project 7086008

Stacey McGuire, Project Administrator, Engineering Department is present to request funding in the amount of \$16,823.07 from the Capital Project 7086008 Fund for the purchase of push button operators for the door to the family barrier free washroom and the door to the large gymnasium at the new WFCU Community Pool. She notes the work will include all labour and materials for the replacement of the existing doors and frames, the addition of door operating hardware, related electrical work, installation and painting. The work will also include the addition of an emergency call system in the family barrier free washroom which would be visible by the pool reception desk staff.

In terms of the installation of push button operators, a question is asked regarding why the accessible doors were not installed initially and why WAAC is being asked to pay for this.

In response to a question asked by the Chair regarding if this project is not funded by WAAC, will the push button operators be installed. S. McGuire responds the push button operators will not be installed if there is no funding approved by WAAC.

It is generally agreed additional quotes regarding the installation of push button operators be provided to WAAC.

The Chair suggests this matter be referred to the Sports and Recreation Subcommittee for further deliberation.

Moved by S. Bagga, seconded by S. McCabe,

That the request for funding in the amount of \$16,823.07 from the Capital Project 7086008 Fund for the installation of two push button operators (including all labour and materials for the replacement of existing doors and frames, door operating hardware,

electrical work, installation and painting) at the WFCU Community Pool **BE DEFERRED** to allow Administration to provide further information and further, that the Sports and Recreation Subcommittee **BE CONTACTED** to allow for input in this matter.

4.2 Proposal for Funding from the Capital Project 7086008

Charmaine Yu, Physiotherapist, Huron Lodge is present to request funding for the purchase of outdoor accessible exercise equipment to be placed on the grounds of Huron Lodge. The "Proposal for Funding (Accessibility) Capital Project 7086008 Fund is distributed and <u>attached</u> as Appendix "A". The Presentation entitled "Accessible Outdoor Exercise Equipment At Huron Lodge" that depicts the various types of outdoor exercise equipment is <u>attached</u> as Appendix "B".

- C. Yu states the outdoor exercise equipment is weather resistant, requires very little maintenance, and is warranted for 10 years.
- G. Jones indicates initially the equipment was intended for Huron Lodge, but certainly can be enjoyed by the community. She states as the residents at Huron Lodge are a vulnerable group, the installation of outdoor exercise equipment will enrich their lives and those of the community.
- S. McCabe advises the installation of outdoor exercise equipment at Huron Lodge can serve as a pilot project for possible future consideration and installation by the Parks Department.

That **APPROVAL BE GIVEN** to an expenditure in the upset amount of \$69,376 (Canadian Funds) to be derived from the Capital Project #7086008 - Accessibility ODA Requirements Fund for the purchase of outdoor accessible exercise equipment (includes the installation of a cement pad) to be placed on the grounds of Huron Lodge, and further, that Huron Lodge **BE REQUESTED** to erect a plaque acknowledging the contribution by the Windsor Accessibility Advisory Committee and City Council.
