8(b) **2016 Proposed Business Licence Fees**

In response to a question asked by G. Conte regarding if the 2016 Proposed Business Licence Fees report has been sent to businesses, C. Robertson responds the matter was advertised in the Windsor Star and on the City of Windsor website.

In response to a question asked by G. Conte regarding why some municipalities can charge different fees compared to other municipalities, C. Robertson responds that the City of Windsor calculates their license fees utilizing a full cost recovery method compared to a risk based method. C. Robertson advises that the City of Windsor will now be recovering the full cost associated with issuing business licenses.

C. Robertson informs the Windsor Licensing Commission that the last time business license fees were increased was in 2005.

The Chair comments on the percentage increase on the proposed business license fees. G. Cian remarks that the percentage increase must be considered along with the actual dollar value.
