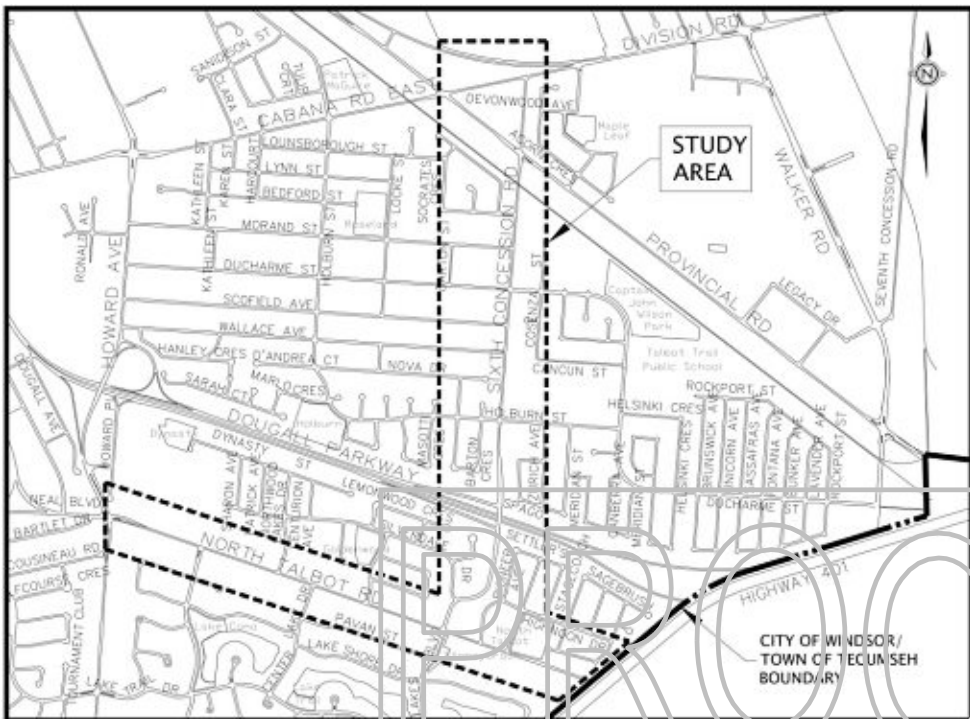


**THE STUDY**

The City of Windsor has completed a Municipal Class Environmental Assessment study (Class EA) to provide an improved 6<sup>th</sup> Concession Road/North Talbot Road corridor that will serve the needs of the transportation system and area growth for a 20-year period. The study area is shown in the key plan below. Dillon Consulting Limited was retained by the City of Windsor to complete the study. The preferred design was presented to the public at the June 26, 2014 Public Information Centre (PIC). Following the PIC the preferred design was reviewed and refined based on comments received.



**THE PROCESS**

The study was completed in accordance with the planning and design process for 'Schedule C' projects of the *Municipal Class Environmental Assessment* (June 2000, as amended in 2007 and 2011) under the *Ontario Environmental Assessment Act*.

**PUBLIC CONSULTATION**

As part of the EA Study, two Public Information Centres (PICs) were held on February 26, 2014 and June 26, 2014. Based on input received at these PICs as well as from technical agencies and other key stakeholders, the Project Team has prepared the Environmental Study Report (ESR) for this study.

The preferred design includes improvements to intersections, active transportation facilities, and the stormwater system.

**ENVIRONMENTAL STUDY REPORT**

By this notice, the ESR is being placed on the public record for review in accordance with the requirements of the *Municipal Class Environmental Assessment* (June 2000, as amended in 2007 and 2011) process. Subject to comments received as a result of this notice and the receipt of all necessary approvals, the project may proceed to the next phase of design.

The ESR will be available for a 30-day public and agency review period from May 12<sup>th</sup>, 2016 to June 10<sup>th</sup>, 2016 at the following locations:

Interested persons are encouraged to review this document and provide comments by June 10<sup>th</sup>, 2016. If, after consulting with the City of Windsor staff and their consultant, there are unresolved concerns regarding this undertaking a person or party may request that the Minister of the Environment and Climate Change order a change in the project status and require a higher level of assessment under an individual Environmental Assessment process (referred to as a Part II Order). Reasons must be provided for the request. Copies of the Request Form must be sent to the Minister of the Environment and Climate Change, 77 Wellesley St. W., 11<sup>th</sup> Floor, Ferguson Block, Toronto, ON M7A 2T5 and the Minister of Environment and Climate Change, 135 St. Clair Ave. W., 1<sup>st</sup> Floor, Toronto, ON, M4V 1P5. A copy of the Part II Order request shall be forwarded to the City of Windsor and Dillon Consulting Ltd. at the addresses listed below. If there are no outstanding concerns by June 10<sup>th</sup>, 2016, the project will be considered to have met the requirements of the Class EA.
