Class Environmental Assessment Study

BANWELL ROAD

From Tecumseh Road East to the CPR Tracks South of Intersection Road

THE STUDY PURPOSE

A Preliminary Design and Class Environmental Assessment (Class EA) Study is currently being undertaken to investigate improvements to the transportation corridor along Banwell Road from Tecumseh Road East to CPR Tracks. The study is being carried out in accordance with the requirements of a Schedule 'C' undertaking of the Municipal Class Environmental Assessment, October 2000, as amended in 2007 & 2011. As identified in the map, the City of Windsor is the proponent for the Study Area from Tecumseh Road East to the CPR Tracks south of Intersection Road.

The purpose of the study is to address the transportation demands of the City of Windsor over the next twenty years, to address the short and long term traffic impacts along Banwell Road and adjacent road network, and to investigate the feasibility of accommodating sidewalks and a multi-use trail for cyclists and pedestrians. Combined, these transportation improvements will enhance public safety in accordance with the Windsor Area Long Range Transportation Study (WALTS).

PUBLIC INPUT

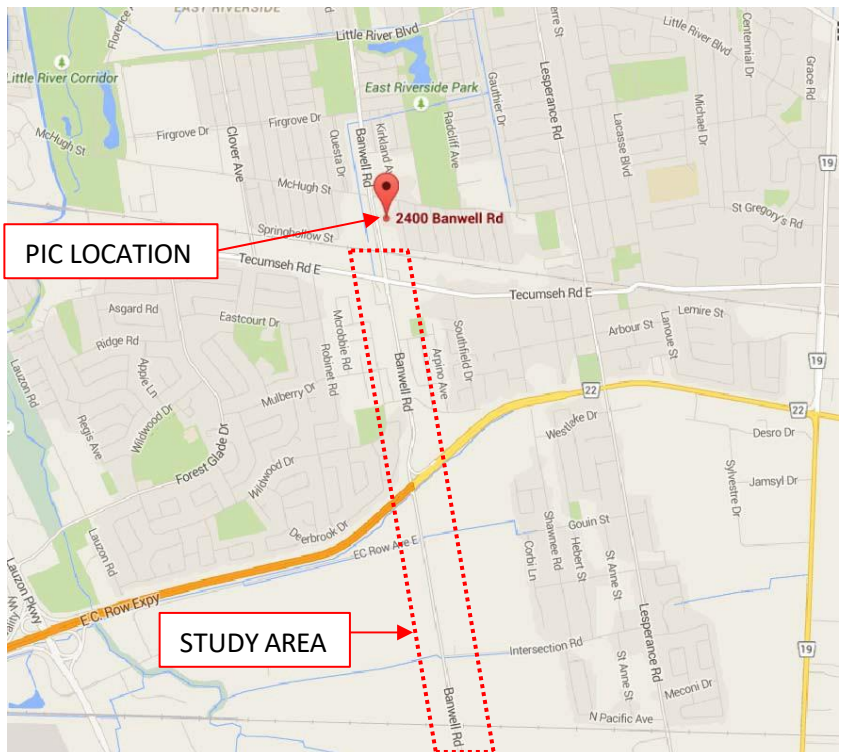
The purpose of the Public Information Centre (PIC) is to present:
