

**Notice of Completion**

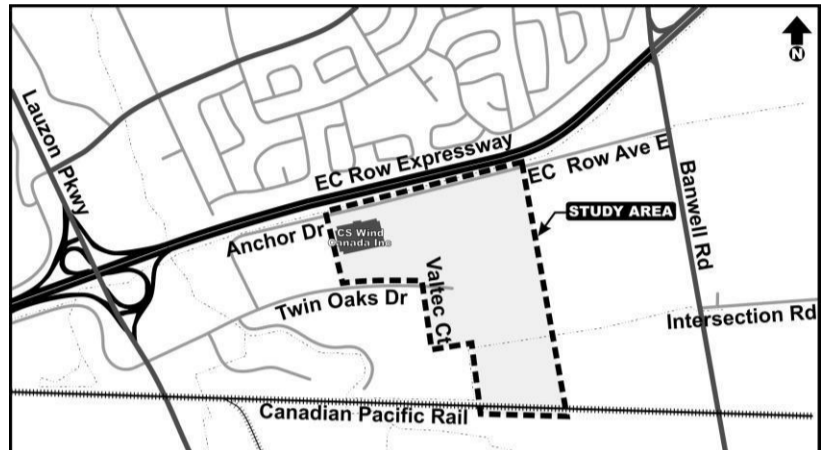
**The Project**

In 2011, the City of Windsor initiated a Class Environmental Assessment (EA) study to investigate environmental issues and alternatives for the extension of Twin Oaks Drive, construction of a rail spur track, relocation of Lachance Drain and related municipal servicing. MMM Group Limited was retained by the City of Windsor to complete the study. The City of Windsor requires the construction of a rail spur track extending northward from the Canadian Pacific Railway main track to the south side of the C.S. Wind property limits. The proposed alignment of the rail spur track crosses lands owned by the City. The City also intends to build a roadway to the east of the railway spur track, relocate a portion of Lachance Drain and to provide site servicing to the adjacent properties.

**The Process**

The study has been conducted as a Schedule „B“ project under the Municipal Engineers Association “Class Environmental Assessment” (2000, as amended 2007 and 2011), which is approved under the Ontario *Environmental Assessment Act*.

A Public Information Centre (PIC) was held in January 2012, which provided further information on project alternatives to interested persons. Consultation also took place throughout the study with local municipalities, and external agencies.



The Environmental Project File for the project has been completed. The Project File documents the preferred alternative, preliminary design work, anticipated environmental effects of the project, and commitments to mitigation measures. The Project File will be filed for agency review, and is available for public review on the City’s website ([www.citywindsor.ca](http://www.citywindsor.ca)) and in hardcopy at the following location(s):

If concerns regarding this project cannot be resolved in discussion with the municipality, a person may request that the Ministry of the Environment make an order for the project to comply with Part II of the Environmental Assessment Act (referred to as a Part II Order), which addresses individual Environmental Assessments. Requests must be received by the Ministry no later than July 5, 2012. A copy of the request must also be sent to the City of Windsor’s consultant at the address below. If no request is received by July 5, 2012, the project will proceed to detailed design and construction.
