To His Worship the Mayor and Members of Council

This is the Willistead Manor Inc. Annual Report to City Council on the affairs and operations of the Corporation for the calendar year 2014.

The Willistead Manor Inc. Board of Directors act in a policy advisory capacity to City Council on the operation of Willistead Manor Inc.; however, the ongoing management of the facility is under the direction of the Office of the Community Development and Health Commissioner. A full report of the activities in the facility may be obtained from that Service Area.

Introduction and Background

The City of Windsor Act, 1981 established a Corporation without share capital under the name of Willistead Manor Inc., with the objective to receive, maintain, manage, control and use donations for charitable purposes for the rehabilitation of Willistead Manor Inc. For the purpose of attaining its objective, the Corporation, Willistead Manor Inc. has the power to accept and hold any real or personal property granted, donated, devised, bequeathed or otherwise conveyed to it and to convert any such property into money and further to advise City Council respecting the following:

- 1. The operation of Willistead Manor Inc.;
- 2. The development and maintenance of the grounds of "Willistead Park";
- 3. The promotion and development of Willistead Manor Inc. as a centre for amusement, entertainment and exhibitions;
- 4. The promotion of meetings, receptions and displays in Willistead Manor;
- 5. The promotion of educational or cultural activities in Willistead Manor;
- 6. The promotion of the performing arts, including musical and artistic work, in Willistead Manor.

Pursuant to Section 12 of By-law Number 1 of the Corporation, enacted October 29, 1981, the Board of Directors shall, once annually, hold a meeting at which will be approved for submission to City Council, a review of the affairs and operations of the Corporation for the year immediately preceding and a financial statement which contains a profit and loss statement and a balance sheet for the year. This report is submitted in accordance with By-law Number 1.



Acquisitions Committee

The Acquisitions Committee met in 2014 to discuss impending projects.

Our main focus was finalizing the details for the men's second floor bathroom. Once all the details were determined, three companies gave proposals and Family Home Improvements was awarded the job.

The committee chose a beautiful textured wall covering in shades of brown that will harmonize with the existing tile floors. We have purchased a period Arts & Crafts light fixture which will hang in an alcove space in the center of the room. A new dark wood shutter blind will be included. The committee designed a custom made double sink vanity in the Chinese Chippendale style. The legs will be fluted with a trellis like carved apron finished in a rich dark walnut colour. A pair of under mount sinks with brushed chrome faucets will be installed. We chose a modeled image quartz countertop in tones of caramel, beige and brown. We will repurpose a pair of gold gilt mirrors from the North Gallery to go above the sinks, and replace the North Gallery with more elaborate detailed gold leaf mirrors. The water closet doors and surrounds will receive a trim molding that will be painted creating a paneled effect. The work will commence in mid March of 2015, with completion that same month. We anticipate a pleasing outcome, consistent with the manor's high quality appointments.

We are grateful to Ms. Margo Bourke for her generous donation of items to be used in the manor, and, as well, some, to be sold in a future sale. The items consisted of a carved settee, brass tea cart, Victorian chairs, a mahogany grandmother clock, a burl wood desk, a gilt mirror, 2 jardinière's, and several small decorative pieces.

Through the donations we are able to enhance the manor, and with funds generated from the sale, we can replenish our décor fund. Therefore, we encourage, and are grateful to the public, to contact us with any possible donation of things that may qualify to that end.

As we move forward in 2015 the committee will be working on a number of projects: a brass hand rail leading to the Library; a pair of pedestals for the candelabras in the Great Hall; refreshing of all the floral arrangements throughout the manor; as well, all paintings will receive minor restoration work; new drapery and recovering of the chairs in the dining room; and a mural will be painted on the conservatory ceiling.

We receive constant compliments on all we do to preserve and maintain the integrity of Willistead Manors' interior. That is our mission as always, and we try to do this in a fiscally responsible way. We thank all those that help us to achieve our desired goals.

His will opened many historical details and pointers to information that followed after Edward's passing. Information included a family lawsuit and many details about Mary's life after Willistead.

Kayla will make presentations of the new public website to the Manor's Board in April 2015; and, to the Parks Department.

All of the website development began in November as a 2014 semester course project that recently resulted in a \$900.00 scholarship award presented to Kayla from the History Department of the University of Windsor.

The Walker website will be added to the City of Windsor's main website.

Manor Club

The fiscal year ending December 31, 2014 concluded with Willistead Manor Inc. continuing its "Manor Club" fundraising campaign. Operating on a budget of \$4,500.00 all of which is dedicated to the Manor Club campaign, various fundraising efforts were undertaken to promote the Willistead Manor Club this year and in the future. A positive operating fund balance from 2013 was included in the 2014 budget, which, combined with normal operating expenses, resulted in a cumulative surplus for 2014 of \$32,849.25.

Eight memberships in the Manor Club were renewed, amounting to \$5,040.20. Six of the Manor Club contributions exceeded the \$100.00 annual membership established by the Board of Directors. Since its inception in 1982, contributions to the Manor Club total \$316,699.64.

As the Board is empowered under Section 6 (c) of its governing legislation

"to pay over from time to time monies received by the Corporation to the City Treasurer and the City shall use any monies so received only for the purposes of operating, renovating and furnishing Willistead Manor".

We will be presenting a cheque to the City Treasurer in the amount of \$5,121.76 to be applied toward the continued restoration of Willistead.

Art-in-the-Park

Art-in-the-Park, co-sponsored by the City of Windsor and the Rotary Club of Windsor (1918), contributed \$34,112.00 to the Willistead Restoration Fund for 2014. This joint effort, which commenced in 1978, has generated \$1,193,324.88 towards Willistead Restoration projects.

Willistead Classic Car Show

The Willistead Classic Car Show event was not held in 2014. This show, which began in 1987, has generated a total of \$209,152.71 toward Willistead restoration projects.

Friends of Willistead

The Friends of Willistead have generated "contributions" totalling \$101,866.00 since their inception in 1982. They have also volunteered countless hours of labour, particularly decorating for Christmas and assisting in furnishings acquisitions.

Furniture and Furnishings

Furniture and furnishings valued at approximately \$489,305.00 have been donated to Willistead over the years by many generous members of the community.

Willistead Capital Restoration

All of the details listed above indicate another successful year for Willistead and the various activities committed to raising funds for the continued restoration of Willistead. The Willistead Capital Restoration Fund has a balance of \$128,388.89 for the year ending December 31, 2014.

Willistead Capital Maintenance

Since it was established in 2005, the Willistead Capital Maintenance Reserve Fund has funded capital maintenance expenditures totalling \$160,000.00.

Willistead Endowment Fund

In 2012, City Council approved the establishment of the Willistead Manor Endowment Fund. The fund is to be used exclusively, and in perpetuity, for the preservation, restoration, and capital improvement of Willistead Manor, and used for any means needed to achieve this purpose. It is intended that the fund be used for infrastructure projects. The minimum capital amount that must be preserved in the fund at all times is set at 50% of the receipted value of life to date contributions to the fund. As at December 31, 2014 the Willistead Endowment Fund has a fund balance of \$6,550.48. The minimum capital balance that must be preserved in the fund as at December 31, 2014 is \$3,279.68.

Conclusion

Combined with the 2014 contribution from Willistead Manor Inc. and the Art-in-the-Park donation, along with the projected 2015 expenditures from the Willistead Capital Restoration Reserve Fund, it is estimated that the fund will have a balance of approximately \$169,311 at December 31, 2015 to be used towards future restoration at Willistead.

The various fund raising activities and volunteer contributions continue to reflect the success enjoyed by Willistead.
