

**ADDENDUM NO. 3  
CABANA/DIVISION CORRIDOR IMPROVEMENTS CONSULTING SERVICES

This addendum amends and forms part of the Proposal Documents. The Proponent shall insert the addendum behind the cover page of the Proposal Documents.

**REVISED SECTION**

1. Item 7.5 on page 10 is revised to eliminate the numbering of Item 7.5. The following content will be merged into Item 7.4 at page 10:

*“The preliminary project limit of this RFP is identified as shown on Figure 1. Key elements required in these Consulting Services will include the following:”*

2. Item 7.4.1.1 is revised and replaced by the following:

*7.4.1.1 Widening Cabana Road to four lanes: detailed design of Cabana Road West from ending point of Cabana Corridor Improvements Phase 2 (west of Dougall Avenue) to west of Northway Avenue and merging into MTO’s land based on the preferred design in the Cabana Corridor EA.*

*7.4.1.1.1. The SP shall complete any and all necessary traffic analysis according to the required horizon year of 25. No interim analysis is required for the multi-phased construction purpose.*

*7.4.1.1.2. Liaison with MTO for the smooth transforming of road, bike lane and pedestrian corridor design into the MTO land.*

3. Item 7.4.1.2 is revised and replaced by the following:

*7.4.1.2 City will provide the following:*

- *Historical annual daily traffic count information and collision records;*
- *Turning movement count and signal timing data at all signalized intersections;*
- *Turning movement count data at all intersections that are potentially proposed to be closed as per Cabana EA;*
- *ADR / AADT volumes on parallel streets which may see an increase in volumes due to the proposed road closures;*
- *Base map survey;*
- *Geotechnical investigation reports.*

*The SP shall review the existing geotech investigation reports, co-ordinate geotechnical investigation and base map survey.*

Except for the contents of this addendum, all other terms and conditions of this proposal remain the same.
