Failure to attend both of the mandatory pre-bid meeting sites shall result in the disqualification of the Proponent and the rejection of any Submission submitted by such Proponent. Safety shoes, hardhats, vests and protective eyewear are required.

For those Proponents that attended the Mandatory Site Meeting held on Friday, January 18, 2019, at Little River Pollution Control Plant and Lou Romano Water Reclamation Plant, attendance is optional only and is not mandatory.

Except for the contents of this addendum, all other terms and conditions of this proposal remain the same.
