BY-LAW NUMBER 8-2014

A BY-LAW TO FURTHER AMEND BY-LAW NUMBER 2-2006, BEING A BY-LAW TO ESTABLISH AND MAINTAIN A SYSTEM FOR THE COLLECTION AND DISPOSAL OF WASTE IN THE CITY OF WINDSOR.

Passed the 20th day of January, 2014.

WHEREAS it is deemed expedient to further amend By-law Number 2-2006 of The Corporation of the City of Windsor for the purpose of enforcing the provisions of By-law Number 2-2006 of the Corporation of the City of Windsor, as amended;

THEREFORE the Council of the Corporation of the City of Windsor enacts as follows:

1. That Section **1.3 Definitions** of By-law Number 2-2006 be amended by deleting the definition of "Garbage Container" and substituting the following therefore:

"Garbage Container means a hard sided container to place garbage in for storage and collection, as set out in Part 3 of this by-law."

2. That Section **1.3 Definitions** of By-law Number 2-2006 be amended by adding the following definition of "Yard" thereto:

"Yard means land that is not a highway, including vacant lots or any part of a lot, which is not beneath a building."

3. That the title for "Part 3 – Receptacles for Garbage, Recyclable Material and Yard Waste" of By-law 2-2006 be deleted and the following title be substituted therefore:

"Part 3 – Receptacles for Storage and Collection of Garbage, Recyclable Material and Yard Waste".

- 4. That Section **3.1 General** of By-law Number 2-2006 be amended by adding thereto Section 3.1.1 as follows:
 - "3.1.1 Every occupant and owner of a residential dwelling unit shall ensure that garbage stored in a yard is placed in a Garbage Container."
- 5. That Section **3.2 Garbage Containers** of By-law 2-2006 be amended by deleting paragraph 3.2.2.
- 6. That Section **5.2 Non-Collectable Waste** of By-law 2-2006 be amended by deleting paragraph p) and substituting the following therefore:

- "p) garbage in loose plastic shopping/ grocery bags or in plastic garbage bags of any kind; and"
- 7. That Section **8 Enforcement** of By-law Number 2-2006 be amended by adding thereto Section 8.3 as follows:
 - "8.3 Entry onto Land
 - 8.3.1 Entry to Inspect
 For the purposes of inspecting any land to determine compliance with the terms of this by-law, the Manager may enter onto any public or private land.
 - 8.3.2 Non-Obstruction of Manager

 No person shall hinder or obstruct the Manager in the enforcement of this by-law or from carrying out an inspection of land."
- 8. That this by-law shall come into force and take effect on the 1st day of March, 2014.
