- III) That the Chief Administrative Officer **DELEGATE** signing of all claims and applicable reports and other such documents, as required as part of receiving the funding from the Natural Infrastructure Fund, to the Executive Director of Engineering, subject to financial content approval from the area’s Financial Planning Administrator or their manager or designate.
