CAO APPROVAL

The Chief Administrative Officer approved the following recommendation:

Report Number: CAO 32/2019

Approved: July 4, 2019

1. That the **CONSENT TO ENTER** is provided to Aecon Construction Group Inc. ("**Aecon**"), as contractor for Enbridge Gas, to enter upon vacant City owned lands, municipally known as 0 Dominion Boulevard, legally described as Lots 258 to 264, inclusive, Registered Plan 558 and Part Block B, Registered Plan 558, closed by R172641 as in R1393832 save and except the easement therein, as shown on the aerial diagram attached as Appendix B (the "**Lands**");
2. The term of the agreement **SHALL BE** from July 2, 2019 and expiring not later than July 15, 2019;
3. Aecon **WILL ENTER** the Lands to be used as a staging and lay down area and for the storage of its materials and equipment;
4. Aecon **SHALL ENSURE** that the Lands and any materials and/or equipment stored or used thereon shall be fully secured by Aecon so that the Lands and all materials and/or equipment are entirely inaccessible to the general public at all times;
5. Aecon **ACKNOWLEDGES** that The Corporation of the City of Windsor (the "**City**") makes no representations or warranties as to the suitability of the Lands for use as a lay down area and/or the storage area for its materials and equipment;
6. Access to the Lands **WILL BE** from Dominion Boulevard;
7. Aecon **AGREES** that, upon termination of the agreement, any disturbance of the Lands resulting from its occupation thereof will be restored at its own costs to the satisfaction of the City Engineer or designate acting reasonably;

8. Aecon **WILL BE REQUIRED** to provide the City with indemnification and require proof of insurance with the following minimal coverage, satisfactory to the Manager of Risk and Insurance:
 - \$5,000,000 Commercial General Liability coverage
 - "The Corporation of the City of Windsor" listed as Additional insured
 - Cross liability coverage
 - 30 days' cancellation notice
9. That the Chief Administrative Officer and the City Clerk **BE AUTHORIZED** to sign the Agreement with Aecon approved as to form by the City Solicitor or designate and content by the City Engineer.
