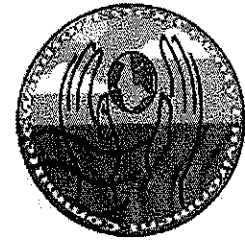

## **ONGOING INITIATIVES**

### **1. Provincially Significant Wetlands Subcommittee**

The subcommittee asked for a deferral of the follow-up report from the Planning department regarding the Ojibway Shores property. At the Environment and Transportation Standing Committee meeting on Wednesday, January 25<sup>th</sup> the report requested by WECEC to the Planning Department regarding re-zoning City property adjacent to Ojibway Shores from industrial to natural heritage was discussed. From this discussion a motion was made to investigate the benefits to linking existing Natural Heritage areas with the Detroit River. The subcommittee will fight for the property again when this new report is brought forward.

The sub-committee has now received a draft copy of the Lake Erie Costal Stewardship Trail concept and will offer any comments to Carolinian Canada.

### **2. Regional Integrated Community Sustainability Plan**

Contact has been made with members from the Inter-Municipal Planning Consultation Committee (IMPCC) to begin discussions with the group regarding a Regional Sustainability Plan.

### **3. Renewable Energy Media Campaign with Generator Design**

Letters requesting support for the renewable energy campaign have been sent to various solar companies in Windsor as well as the Economic Development Corporation and the Regional Chamber of Commerce. Mark Bartlett plans on following up with these companies and agencies in order to discuss our project in more detail with them.

The campaign message still needs to be finalized and approved by the Committee before our campaign will launch.

### **4. Student Representatives**

An updated Terms of Reference for our Committee has been approved by City and County Councils along with our recommendation to replace the City and County Citizen positions with Student positions.

The format for the St. Clair student representative has been determined. The elected student government president will be put forward to sit on our Committee. This has been written into the duties of the student government president. By the middle of March, 2012 student government elections will be complete and we will receive an application and resume from the president. She/he will be recommended to the Standing Committee and will hopefully have approval from the City and County by May 1<sup>st</sup> when her/his term begins. We will hopefully have a student from St. Clair at our monthly meeting in May. Their term will be one year until the next student government elections which occur on a yearly basis.

A similar request has been made of the University of Windsor student government. Our proposal has been received by the student council president and we are awaiting his response.

#### **5. Water Quality Subcommittee**

This subcommittee met for the first time this month. We talked about a variety of issues including non-point sources of phosphorous loading into the Detroit River, a possible Provincial Algal Bloom Strategy, public awareness campaigns etc. We would like to engage authorities such as the Ontario Ministry of Agriculture, Food and Rural Affairs (OMAFRA), the Ministry of the Environment (MOE), and the Essex County Federation of Agriculture (ECFA). We also hope to produce a "fact sheet" detailing the issue.

#### **6. Transportation Subcommittee**

The subcommittee has received information from Brian Masse's office regarding the high speed rail campaign and will continue to work with the Chamber of Commerce to formulate a united request to the Province in support of high speed rail.

### **IMPORTANT UPDATES AND INFORMATION**

#### **1. Earth Day 2012**

Earth Day 2012 will take place on Sunday, April 22<sup>nd</sup> at Mic Mac (displays and activities) and Malden (native plant garden) Parks. The theme this year is local food – "I like my food naked, near and natural". The Committee has purchased a booth and so will need volunteers during the day from 10am until 3pm.

**Meeting Minutes:**

**1. Windsor – Essex Parkway Meeting with the Windsor Essex Mobility Group (WEMG)**

The sub-committee met before the scheduled meeting with the WEMG and outlined the core issues to be discussed. These included, principally, the Provincially Significant Wetland (PSW) compensation required as a result of the Parkway and the resulting permits required, the need for a habitat compensation update, as well as the role of WEMG's technical working group and how the sub-committee might be able to access them. In addition, a notice of motion was prepared to recommend City and County Councils to request a meeting with the Ministry of Transportation (MTO) and Infrastructure Ontario (IO) and WEMG on behalf of WECEC.

**Meeting Outcome with the WEMG:**

The meeting with the WEMG was lead by Andreas Stenzel (PIC / WEMG) with attendance by Joel Foster (MTO), Barb Macdonell (MTO), several MTO staff, Elizabeth Reimer (MNR), Michael Cooke (City Planning) and several other resource people. Charlie Wright met the group there.

*Mr. Stenzel led us through the process of the compensation strategy, 3:1 compensation rational and eventually to the footprint of the compensation areas. The highlights of their plan was to provide compensation where possible adjacent to existing PSW features, as contiguous as possible and included additional land acquisition to support a 120 m buffer around the 15 Ha of compensation wetland to be developed. All of the land acquisition was complete and there was no further impedance to this plan. Two primary unfragmented blocks were identified to us on a map, the largest being north of Armanda to the parkway and an area in the vicinity of the current Huron Church / EC Row convergence. Several positive elements have been realized by this plan (recognition of the 3:1 ratio and the 120 m buffering sets valuable precedence) and it is our recommendation that this compensation strategy be supported.*

*The discussion then went to additional opportunities including compensation value for linking the LaSalle Woodlots to Spring Garden ANSI through the Todd Lane / Lennon Drain corridor and similarly the Black Oak Heritage Park area to the Ojibway Complex through the Ojibway Parkway "approaches". The MTO at this point was not willing to undertake any discussion on the Ojibway option and was reluctant to discuss the Todd Lane linkage feature. Armed with several concept drawings including work done by*

*Jonathan Choquette, which was familiar to the WEMG group, Joel Foster stated that the project had finished purchasing property and that this corridor was complicated by services, road works and inadequate linkage opportunity. The group set out to identify the opportunity for these much larger linkage concepts and were left with the impression that there may be another look at the Todd Lane / Lennon Drain opportunity but Ojibway / Black Oak was not in the mandate and is a Federal Bridge issue. The notice of motion previously mentioned was dropped as it wasn't required.*

**Action:** Phil will contact Andreas Stenzel to present the wetland compensation plan to the full committee once it has been fully included into their working plans.

## **2. Ojibway Shores Report to the Environment and Transportation Steering Committee**

The second report regarding rezoning is scheduled to go before the committee Wed February 22 at 4:30. The committee felt it was important to submit to the planning department several key issues for this report including work done by the DRCC Habitat Working Group. Alan indicated he was not able to attend this meeting.

It was decided to request a deferral of the report to March through Councillor Halberstadt allowing time to prepare for the submission and meet with the planning department.

**Action:** Alan to request a deferral of the report to March and organize a meeting with City Planning, the PSW Committee and others interested.

## **3. Wetland Evaluations of Publically Owned Properties**

It has on a couple of occasions recently been brought to the committee's attention that publically owned properties which have wetland characteristics have not been evaluated for provincial significance. The City owned portion of the St. Clair Woodlots had not been evaluated and Mathew Child confirmed at the WECEC meeting of January 5<sup>th</sup> that the ERCA owned Devonwood Conservation Area was not identified as a PSW contrary to the general understanding of the Committee.

WECEC has had success in requesting evaluations for "suspect" PSW woodlots owned by the City of Windsor which has afforded those woodlots the highest degree of protection, a step which may have contributed to the St Clair Woodlot debate. ERCA is a regulatory agency as well as a resource with respect to PSW's and their protection, yet properties in their care have not been identified and designated.

*Notice of Motion: That the City of Windsor undertake; and the County of Essex recommend to the Essex Region Conservation Authority and to Essex County*



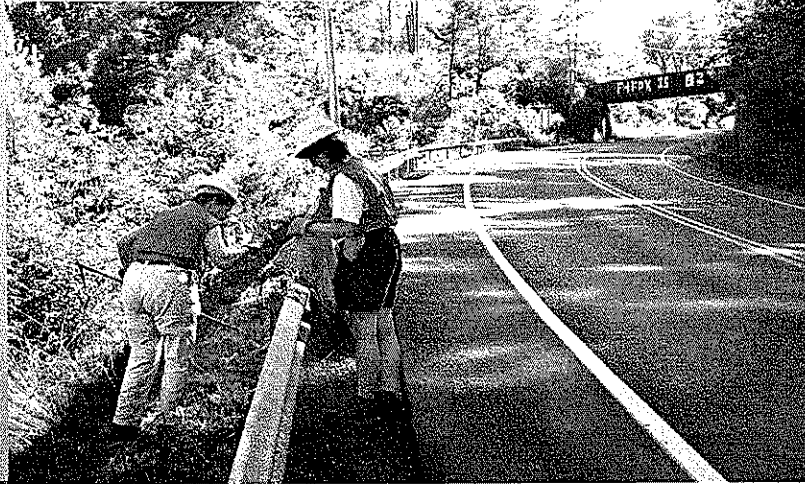
*Municipalities; to identify potential candidate provincially significant wetlands in their ownership and have them evaluated through the Ontario Wetland Evaluation System.*

#### **4. St. Clair Woodlot Sale**

A brief discussion on the City sale of a portion of the St. Clair Woodlot to St. Clair College was concluded with Alan wishing to pursue discussions with the developer who owns other portions of the woodlot. If the woodlot becomes constrained due to species at risk present and/or the parkway footprint there may be an opportunity for the City to establish ownership of all remaining parcels.

Action: Alan will pursue as a City Councillor.
