

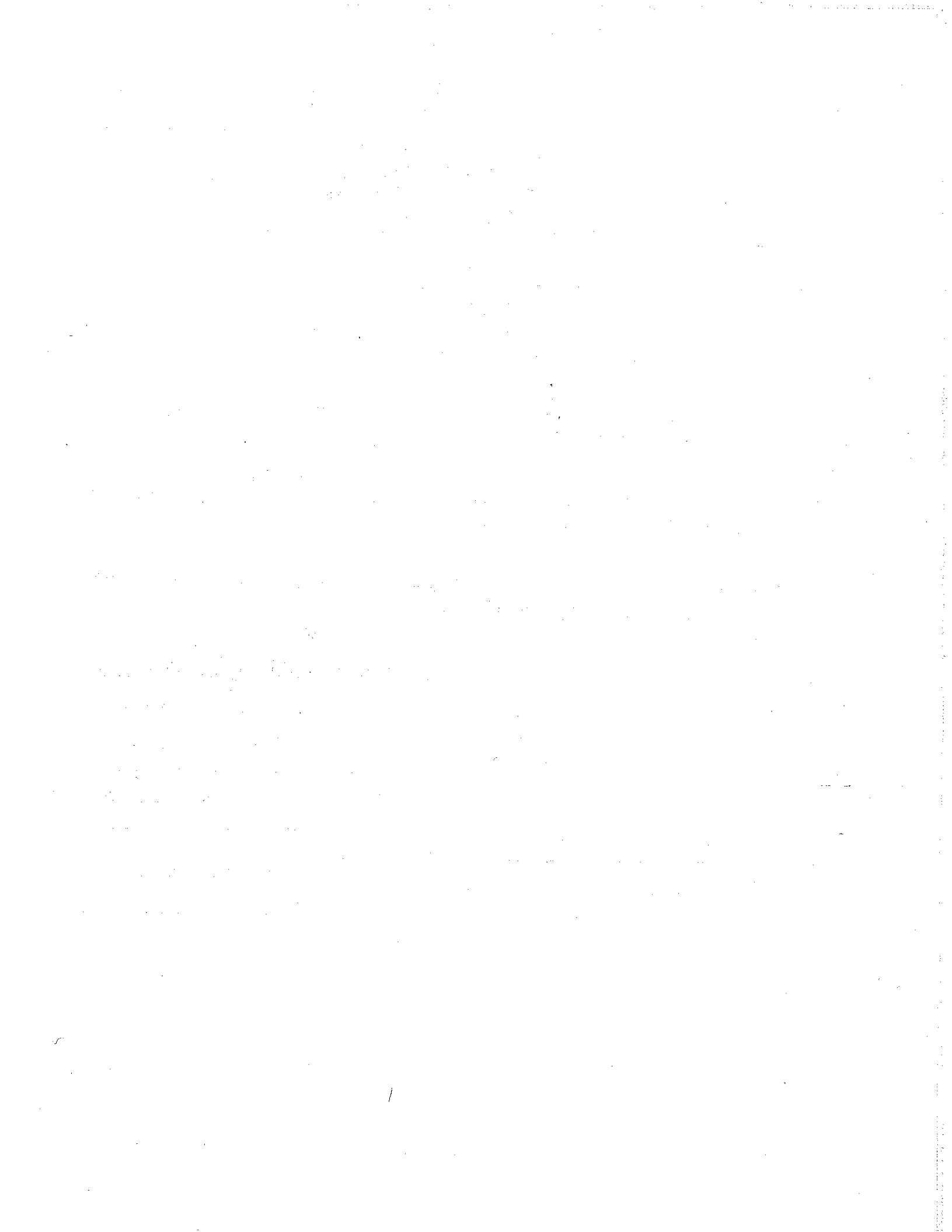

**7(b) Kathy Lenahan – Owner of Prohibited Dog “Diva”**

No one is present to speak to the matter.

A. Kalinowski advises Kathy Lenahan, owner of “Diva” contends the dog is a boxer and not a pit bull but has not provided verification of the breed.

**WLC18/12** That the dog owned and harboured by Kathy Lenahan **BE DEEMED PROHIBITED.**

**7(c) 002322382 Ontario Inc. o/a Crystal Auto Sales & Services – Salvage Yard**

Mr. Hussain Al Ameri, owner Crystal Auto Sales, Mr. Bassin Al-Hamidawy, Manager and Mr. Peter Morgan and Mrs. Sandra Morgan, neighbours are present regarding this matter. Also present is Mr. David Cree, President and CEO, Windsor Port Authority.

Mr. and Mrs. Morgan advise they do not support this salvage yard as their adjacent property will be devalued and are concerned with the presence of combustible materials.

Mr. David Cree cites several reasons for opposing the granting of a business licence for a salvage yard at 3496 Sandwich Street. He indicates the Port Authority has a vested interest in this application and he states a salvage yard in this location is not an appropriate use for this site. He states there are problems with the existing fence, and break-ins and the setting of fires may occur.

Mr. Al-Ameri states the yard will be cleared of tires.

In response to a question asked by Councillor Hatfield regarding the number of complaints received since the business operation commenced in 2001, M. Chantler responds only 3 complaints have been received.

Moved by Councillor Sleiman, seconded by J. Fathers,  
**WLC19/12** That the application for a Salvage Yard Licence submitted by Mr. Hussain Al Ameri o/a Crystal Auto Sales & Service, 2496 Sandwich Street, Windsor **BE APPROVED WITH CONDITIONS** subject to the following:

1. That piles of material shall not exceed 6 feet in height;
2. That the owner develops a rodent control protocol and submit it to the Licence Commissioner;
3. That the owner, within seven (7) days of this decision, ensure all salvage material is at least 10 feet away from the boundary;
4. That By-law Enforcement inspect the premises quarterly;
5. That the applicant provide a letter from the City of Windsor Fire Department proving that the premises are clear of any combustible materials or other hazards;
6. That the owner has a proper program in place for the disposal of combustible materials.

And further, that the neighbours **ARE NOTIFIED** to contact 311 to advise of any by-law infractions such as noise concerns or piles of material being stacked too high.

- Vehicles must be stored inside existing storage building at 1350 Crawford Avenue at the end of each business day.

“(c) The colour of the vehicle’s bumpers, trim, mirrors, roof racks and tires shall be acceptable if they are as originally supplied as black, grey or chrome, by the manufacturer of the vehicle or painted in one of the two body colours of the broker’s colour scheme; and

That Council adopt By-law \_\_\_\_\_ attached hereto as Appendix “A”.
