



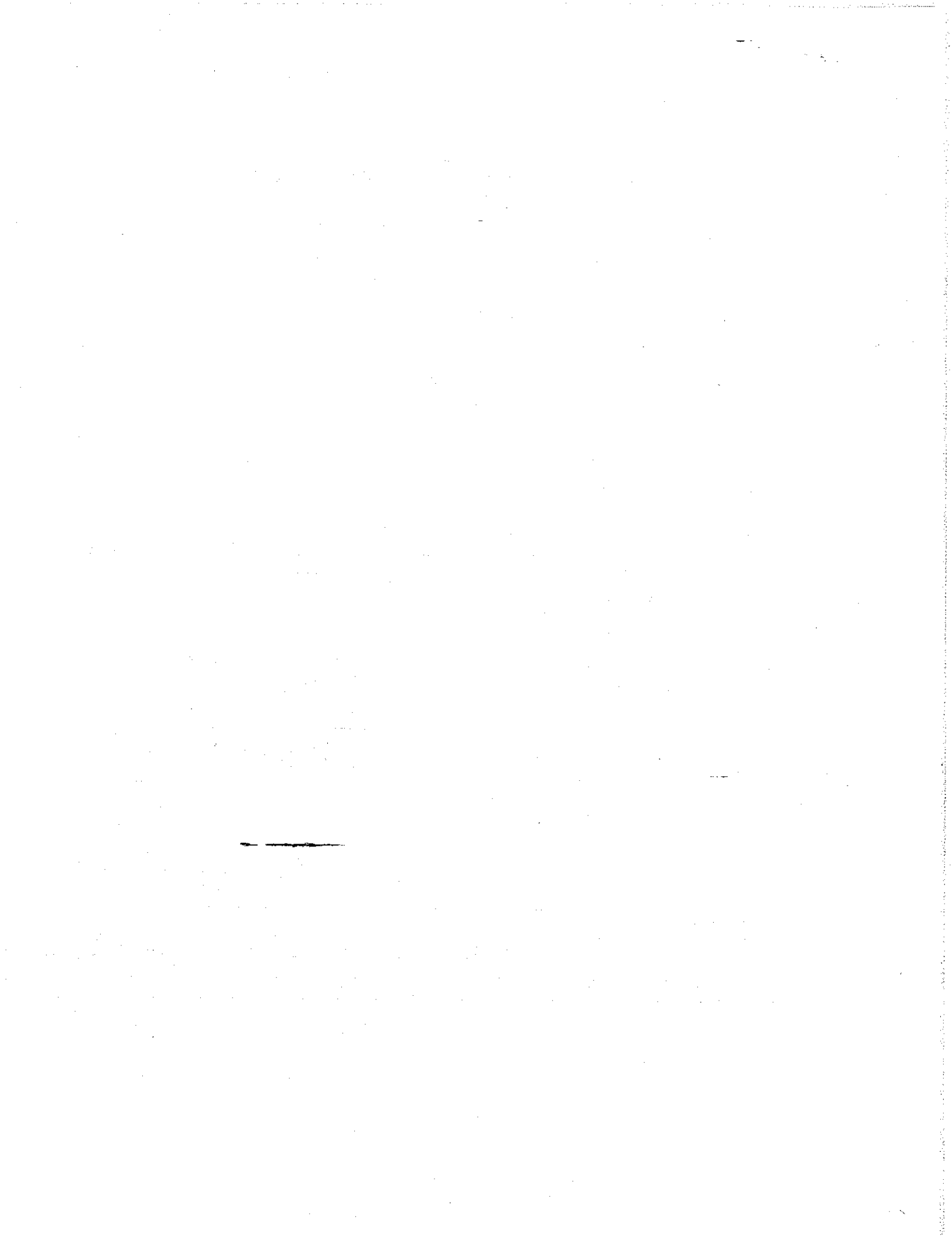

6. **BUSINESS ARISING FROM THE MINUTES**

6.1 **Green Speaker Series Update**

A. Parent advises approximately 70 people attended the Green Speaker Series held on July 8, 2014 at the Ojibway Nature Centre. She indicates Susan Chan, speaker did an excellent job in orating the topic of neonicotinoids (found in pesticides) which may be threatening pollinators and the agricultural system.

Moved by J. Gardner Costa, seconded by P. Henshaw,
That **APPROVAL BE GIVEN** to an expenditure in the upset amount of \$1,000 for the next Green Speaker Series to be held on a date (October or November 2014), time and location to be determined.

8.3 Provincially Significant Wetlands

J. Gardner states a "bioblitz" of Ojibway Shores was recently held and a report will be provided to WECEC.

P. Roberts indicates that the Ministry of Natural Resources has recently completed a biological inventory (updated mapping system) of Ojibway Shores and has identified the property as an ANSI with a PSW footprint.

P. Roberts advises the Phase 3 tree planting initiative at the Windsor Airport has been vetted through City Administration and is seeking approval from YQG.

8.4 Water Quality

8.4(a) 8th Canada-Ontario Agreement on Great Lakes Water Quality and Ecosystem Health

A. Parent refers to the letter sent by the WECEC Co-Chairs to the Ministry of the Environment (Land & Water Policy Branch) dated June 5, 2014 commending the MOE for the development of the 8th Canada-Ontario Agreement on Great Lakes Water Quality and Ecosystem Health.

8.4(b) International Joint Commissions Lake Erie Ecosystem Priority (LEEP) Report

Moved by T. Stomp, seconded by M. Nelson,

WHEREAS in February of 2014 the International Joint Commission released the Lake Erie Ecosystem Priority (LEEP) report providing policy advice on solving the algae bloom issue in Lake Erie; and

WHEREAS the LEEP report concludes that the Maumee and Detroit River are the largest contributors to the phosphorus loading in Lake Erie, and that 66% of the bloom is from agriculture/rural nonpoint sources, mostly from Ohio. In addition, at least half of the annual load occurs in the spring (March 1 – June 30) but 90% of the annual load is deposited in select rain events; and

WHEREAS the recommendations of the LEEP report include, but are not limited to:

- Setting Loading Targets:
 - Proposed 37% reduction in total phosphorus (TP) and 41% reduction in dissolved reactive phosphorus (DRP) for the Maumee River and Lake Erie west basin tributaries (includes the Detroit River);
 - Proposed 46% reduction in TP and 78% reduction in DRP from the Lake Erie west basin and central basin tributaries.
- Developing Agriculture & Non-point Solutions – provide incentive and regulatory interventions focused on:
 - the critical March-June period;
 - priority watersheds;
 - mandatory certification standards for fertilizer applicators;

- linking insurance with conservation performance;
- ban fertilizer applications on frozen ground;
- mandatory septic inspections.
- Urban Areas:
 - improve adoption of green infrastructure;
 - prohibit sales and use of phosphorous fertilizers for lawn care (with some exceptions).

THEREFORE BE IT RESOLVED that City and County Council **RECEIVE** the Lake Erie Ecosystem Priority report and its recommendations and strive to implement them where possible;

And further **BE IT RESOLVED** that City and County Council send letters to the Ministry of the Environment and the Ministry of Agriculture inquiring as to how the proposed recommendations will be implemented in Ontario.

Carried.

8.4(c) Rain Garden Demonstration Projects in all Windsor & Essex County Municipalities

Moved by C. Wright, seconded by T. Stomp,

WHEREAS rain gardens are designed to absorb runoff from impervious urban areas diverting it from storm drains or combined sewers therefore recharging groundwater, diverting stormwater from municipal infrastructure and reducing polluted runoff into the local water bodies; and

WHEREAS rain gardens constructed with native plants improve biodiversity and provide food for pollinators; and

WHEREAS the Essex Region Conservation Authority (ERCA) has already begun working with member municipalities to create rain gardens at various locations including Harrow, Leamington, and Windsor; and

WHEREAS ERCA staff will provide expertise to design and build a rain garden and help monitor its effectiveness;

THEREFORE BE IT RESOLVED that every Windsor and Essex County member municipality strive to complete a demonstration rain garden by the end of 2015 in partnership with the Essex Region Conservation Authority.

That City Council **BE REQUESTED** to endorse segregated bike lanes on Cabana Road as identified in the report of the Transportation Planning Engineer dated June 25, 2014 entitled "Cabana Road Active Transportation Facilities for the Windsor Loop and CQ28-2013 Feasibility of Constructing a Pilot Segregated Cycle Lane".

Hi Alan and Drew:

First off let me say Alan, that you will be missed greatly as a strong supporter of environmental concerns on City Council. I do hope that you will continue to be an active member of the WECEC.

Today, I want to talk about the tremendous potential harm which will be inflicted upon CNHS 24 (Roseland Woods) if the proposed development is approved by City Council.

Candidate Natural Heritage Site no. 24 stands to lose 75 % of its forest!

The South Windsor Development Company, with the aid of Dillon Consulting, plans to reduce this forest from 18.1 acres to 4.5 acres. A tragic loss of 13.6 acres!

Alan and Drew, we currently have 13 CNHS's within the city of Windsor which are completely private!

Schiller's bush CNHS 9 has 17.3 acres of forest and the CNR Vanderwater Yard CNHS 29 has 68.6 acres! Thirty large oak trees at the Yard have a dbh of 50cm. and 3 have a dbh of over 100cm.!

At Roseland Woods, CNHS 24, we have 12 trees larger than 50cm. dbh and one Burr Oak which is 93cm. dbh!

Dillon Consulting told me today that they will try to save some of the larger trees but to completely strip bare 75% of CNHS 24 is to me unconscionable!

So the question remains, does the city of Windsor have the authority and the will to protect our last remaining CNHS's which are privately owned?

Hopefully, with your influence, The South Windsor Development Company and Dillon Consulting can redraw their development map and save a much greater portion of CNHS 24!
