



6. **BUSINESS ARISING FROM THE MINUTES**

6.1 **Green Speaker Series Update**

A. Parent reports Paul Helm, Ministry of the Environment has been confirmed to speak on November 12, 2014 at 7:30 p.m. at the Ojibway Nature Centre. She notes the Field Naturalists Club will cover the room rental at the Ojibway Nature Centre and states there is no cost associated with Paul Helms's travel or accommodations.

A. Parent expresses concern she has been unable to retain a videographer to film a phosphorous campaign video (although there is \$1,000 budgeted for this endeavour). It is generally agreed the Environment & Sustainability Coordinator will contact the DRCC Coordinator to determine if a contact for a videographer can be provided.

A. Parent states ERCA and the City of Windsor are continuing to coordinate bringing in members of the Credit Valley Conservation Authority and/or the Toronto Region Conservation Authority to discuss Low Impact Development with municipal staff. The speaker coming in could also be a WECEC Green Speaker for a public event.

Councillor Halberstadt, Co-Chair indicates he will contact Pat Jeflyn and Kim Kristy, Canadian Arts Productions, to ascertain if they are available to produce a low impact development video.

- Suggests a recommendation be made to change the zoning of the city-owned property adjacent to Ojibway Shores as a result of the Province designating pieces of both properties as Provincially Significant Wetlands.
- City legally bound to service Port Authority lands.
- City has been previously unable to change zoning from Port Industrial to natural heritage land.
- Jeff Watson, M.P. – Essex is interested in protecting Port Authority lands. He will broker a meeting with Michael Cautillo, President and CEO of Windsor Detroit Bridge Authority
- Suggestion for WECEC to forward interest in these lands to Jeff Watson's office.
- PSW Subcommittee to formulate a Notice of Motion.
- PSW mapping has been provided to the city from the Ministry of Natural Resources as an update.
