



## The Corporation of the City of Windsor

### Mayoral Decision MD 14-2024

WHEREAS pursuant to Part VI.1 (Special Powers and Duties of Head of Council) of the *Municipal Act, 2001*, Section 284.16 (Powers and duties re. budget) and in accordance with this section and subject to the regulations, the powers and duties of a municipality with respect to proposing and adopting a budget are assigned to the head of council of the municipality.

AND WHEREAS pursuant to Part VI.1 of the *Municipal Act, 2001*, Ontario Regulation 530/22, section 9(1) The head of council may, for the purpose of raising an additional general upper-tier levy or a special upper-tier levy in the year under section 311 of the Act or a general local municipality levy or a special local municipality levy in the year under 312 of the Act, as the case may be, prepare a proposed budget amendment for the municipality;

THEREFORE I, Drew Dilkens, Mayor of the City of Windsor have prepared a proposed budget amendment for the municipality; and,

I am providing the proposed budget amendment to each member of council and the clerk; and,

I am making the proposed budget amendment available to the public.

I direct the Clerk to include the proposed budget amendment on the agenda for the May 13, 2024 Council meeting at which time council may pass a resolution making an amendment to the proposed budget amendment.

Ontario Regulation 530/22, section 9(4) provides that if council does not pass a resolution at the May 13, 2024 council meeting making an amendment to the proposed budget amendment, then the proposed budget amendment shall be deemed to be adopted by the municipality.


Ontario Regulation 530/22, section 9(5) provides that the head of council may veto a resolution passed by council at the May 13, 2024 council meeting by providing within 5 days after the May 13, 2024 council meeting, to each member of council and to the clerk on the day of the veto, a written veto document that includes the veto and the reasons for the veto.

Ontario Regulation 530/22, section 9(7) provides that if the head of council vetoes the resolution, the resolution shall be deemed not to have been passed by council.

Ontario Regulation 530/22, section 9(8) provides that if the head council does not veto the resolution, then the proposed budget amendment shall be deemed to be adopted by the municipality.

Ontario Regulation 530/22, section 9(9) provides that within 10 days of the head of council veto of the resolution, council may override the head of council's veto if two thirds of the members of council vote to override the veto.

Ontario Regulation 530/22, section 9(12) provides that if council overrides the head of council's veto, the resolution shall be deemed to be passed by council and the proposed budget amendment is deemed adopted by the municipality.
