f) Terms and Conditions Easement to be registered will include Grantee's standard easement schedule

Any disturbance of the Easement Lands or any lands at Windsor Airport (Your Quick Gateway (Windsor) Inc.) caused by the Grantee, will be restored at the Grantee's sole cost, to the satisfaction of the Director of Operations, YQG, or designate; and,

II. THAT the Chief Administrative Officer and City Clerk **EXECUTE** any required written documents satisfactory in form and content to the City Solicitor and that the transaction **BE COMPLETED** electronically pursuant to By-Law 366-2003 and that the City Solicitor or designate **BE AUTHORIZED** to sign any documents related to the completion of a real estate transaction.
