- IV) THAT the Chief Administrative Officer **DELEGATE** the signing of all claims and applicable reports and other such documents, as required as part of receiving the funding from the Homelessness Reduction Innovation Fund (HRIF), to the Executive Director, Housing & Children's Services, or designate, subject to all documentation
