THAT the Chief Administrative Officer **DELEGATE** the signing of all claims and applicable reports and other such documents, as required as part of receiving funding under the Independent Electricity System Operator's past and current Demand Side Management Frameworks, to the Executive Director, Capital Planning & Corporate Energy, subject to all documentation being satisfactory in technical content to the Manager, Energy Initiatives and in financial content to the area's Financial Planning Manager, or designates; and,
- IV. THAT funding received through the various incentives offered through Independent Electricity System Operator's past and current Demand Side
