THAT the Chief Administrative Officer PRE-APPROVE and AUTHORIZE Administration to use the contingency allowance identified herein, for any amendment(s) or change requirement(s)/directive(s) and additional services related to the works provided the amendments do not exceed the approved budget amounts, pursuant to the Purchasing By-Law 93-2012 and amendments thereto; and,
- IV. THAT the CAO and City Clerk EXECUTE any amendment(s) as may be required, provided that the amendments(s) are within approve budget amounts, pursuant to Purchasing By-Law 93-2012 and amendments thereto, satisfactory in legal form to the City Solicitor or designate, in financial content to the City Treasurer or designate and in technical content to the Executive Director, Parks, Recreation and Facilities or designate.
