The Chief Administrative Officer approved the following recommendation:

**Report Number: CAOP 41/2026**

**Approved: Tuesday, April 7, 2026**

- I. THAT the CAO **APPROVE** the one-year extension of the agreement with Rapid Sewer Data Corp., RFT 29-25, approved under CAOP 21/2025, for the provision of zoom camera sewer inspection, for the period March 07, 2026, to March 06, 2027; and further,
- II. THAT the Purchasing Manager **BE AUTHORIZED** to amend Contract Purchase Order 7453 to Rapid Sewer Data Corp., for the provision of zoom camera sewer inspection, under the same terms and conditions as the original agreement, save and except the agreement term shall be extended to March 06, 2027, with no change to the existing to an upset limit of \$974,154.50 excluding HST, satisfactory in financial content to the City Treasurer, and technical content to the City Engineer; and further,
- III. THAT the CAO **AUTHORIZE** administration to continue to use the contingency amount previously approved under CAOP 21/2025, available in the Flood Abatement Measures Project # 7169001, as noted herein, as required for any change order requirements or directives, satisfactory in financial content to the City Treasurer and in technical content to the City Engineer; and further,
- IV. THAT the Purchasing Manager **BE AUTHORIZED** to amend Contract Purchase Order 7453 to Rapid Sewer Data Corp., for any additional amendments that may be required, provided those amendments are within the Flood Abatement Measures Project # 7169001, as noted herein, pursuant to Purchasing Bylaw 93-2012 and amendments thereto, satisfactory in financial content to the City Treasurer, and technical content to the City Engineer.
