- I. THAT the CAO **APPROVE** the award of Tender No. 38-26, for the purpose of the placement of surface asphalt on Engineering and Development projects as described in this report, and for the milling and asphalt resurfacing of the Dougall Parkway eastbound off-ramp and Dougall Parkway westbound on-ramp at Sixth Concession Road to the low bidder, Mill-Am Corporation for \$1,048,400 (excluding applicable taxes); and further,
- II. THAT the CAO and City Clerk **EXECUTE** an agreement with Mill-Am Corporation in the amount of \$1,048,400 (excluding applicable taxes) satisfactory in form to the City Solicitor, in financial content to the City Treasurer, and in technical content to the City Engineer; and further,
- III. THAT the CAO **AUTHORIZE** administration to issue any change order(s) using available funds as detailed herein or available funds remaining in the respective Engineering Department projects, for any change order requirements / directives related to Tender No. 38-26 provided that the change order amounts do not exceed the approved budget amounts; and further,
- IV. THAT the CAO and City Clerk **EXECUTE** any amendment(s) as may be required, pursuant to Purchasing Bylaw 93-2012 and any amendments thereto, provided the amendments are within the approved budget amounts, noted herein, satisfactory in form to the City Solicitor, in financial content to the City Treasurer, and in technical content to the City Engineer.
