- I. THAT the CAO **APPROVE** the award of Tender 24-26 for the cold milling and asphalt paving of the westbound direction of E.C. Row Expressway from Central Avenue to Walker Road, including the eastbound on and off ramps at Howard Avenue and both eastbound off ramps at Lauzon Parkway to the low bidder, GIP Paving Inc. for \$2,694,400 (excluding applicable taxes); and further,
- II. THAT the CAO and City Clerk **EXECUTE** an agreement with GIP Paving Inc. in the amount of \$2,694,400 (excluding applicable taxes) satisfactory in form to the City Solicitor, in financial content to the City Treasurer, and in technical content to the City Engineer; and further,
- III. THAT the CAO **AUTHORIZE** administration to issue any change order(s) funded using available funds remaining in the budget as noted herein, for any change order requirements / directives related to Tender No. 24-26 provided that the change order amounts do not exceed the approved budget amounts; and further,
- IV. THAT the CAO and City Clerk **EXECUTE** any amendment(s) as may be required, pursuant to Purchasing Bylaw 93-2012 and any amendments thereto, provided the amendments are within the approved budget amounts, noted herein, satisfactory in form to the City Solicitor, in financial content to the City Treasurer, and in technical content to the City Engineer.
