Dear Sirs,

I am counsel for Buu Quoc Tran. His company owns the building located at 1165 Wyandotte Street West, Windsor. Currently, a grocery store known as Ugarit Market operates there.

We understand that a numbered company known as 1000621124 Ontario Inc. owns the property in question, namely, 673 Wellington Avenue, Windsor, and that they have made an application to the City of Windsor to amend the zoning of said property to add a special policy area to allow a retail store as an ancillary use. The Corporation Profile Report identifies the Directors of that corporation as Muayad F R Abualhayja and Howidi Mohammad, and a true copy of said Profile Report is attached hereto as Exhibit "A".

Currently, Mr. Abualhayja is the tenant operating Ugarit Market through his corporation, 2713796 Ontario Inc. and this business is located at 1165 Wyandotte Street West. Please find attached as Exhibit "B" a true copy of the Corporate Profile Report for the said corporation naming Mr. Abualhayja as a director. Also, please find attached hereto, as Exhibit "C", a true copy of the first page of the Lease Agreement between Mr. Tran and Mr. Abualhayja, concerning 2713796 Ontario Inc.

My client has expressed significant concerns regarding environmental implications related to the property, 673 Wellington Avenue, formerly occupied by Coulter Radiator, Manufacturing and Refurbishing, which operated out of those premises for many years. The operations of Coulter primarily involved radiator repairs that utilized aluminum, various chemicals, toxic waste, and aggressive cleaning agents. Given that Coulter functioned as an original equipment manufacturer (OEM), the proposed establishment of a grocery market on this site raises serious concerns about contamination.

My client is particularly apprehensive about the potential health risks to consumers who may frequent the grocery store due to the possibility of toxic materials being present in a facility designated for the sale and consumption of food. It is hoped that the Ministry of the Environment

and the Ministry of Health will conduct a thorough investigation of the property before any occupancy, contingent upon approval of this application. The transformation of a manufacturing use to a commercial use involving food products necessitates scrutiny, particularly in light of the existing site conditions. Therefore, the involvement of both the Ministries of the Environment and Health is essential.

We have acquired an affidavit from a neighbour, Mr. Patrick Johnson, regarding the business practices of the current tenants, which is attached hereto as Exhibit "D". Mr. Johnson observed the delivery of frozen chickens on a pallet outside the existing store, where rats and cats were seen scavenging the chickens. He witnessed conditions of contamination and unsanitary waste, noting that the remnants of the frozen chickens, which the rats and cats did not consume, were subsequently sold in the grocery store to unsuspecting customers.

This particular area within the City of Windsor has been identified as having a high crime rate, which increases the likelihood of criminal activity impacting the customers of the grocery store. There is a considerable concern regarding the safety of residents residing in the nearby residential properties.

In addition, it has come to our attention that Mr. Muayad F. R. Abualhayja is facing a criminal charge of assault. This information represents an aggravating circumstance that raises further concerns regarding the owner and proposed tenant of the new grocery store. Attached hereto as Exhibit "E" is a true copy of the aforementioned criminal charge.

Moreover, there are currently an adequate number of food markets within the immediate vicinity of the proposed development. As a result, there is no need for an additional food market, given the presence of existing establishments within walking distance of the proposed location.

We would like to inform the Committee of the various work orders that have been issued due to non-compliance with the City of Windsor By-Laws, concerning Mr. Abualhayja and his businesses. One notable instance is the Sign By-Law violation from 2024 involving the owners of 673 Wellington Avenue, who erected a sign without first obtaining the requisite permit. Following the issuance of an Order, the owner subsequently acquired the necessary permit.

Additionally, the Committee may be unaware of the numerous notices issued by the City of Windsor to the owner of 1165 Wyandotte Street West pertaining to infractions committed by the tenants of the associated grocery store, specifically the Applicants referenced herein. This lack of awareness may stem from the fact that these infractions are not documented in the publicly accessible Property Record Search. The infractions in question pertain to the Yard Maintenance and Anti-Littering By-law. Attached hereto as Exhibit "F" are the relevant Notices and charges associated with the clean-up efforts. It is important to note that the City has classified Mr. Tran as a "repeat offender" due to the frequency of infractions attributed to his tenants.

We would like to bring to the Committee's attention the ongoing littering and garbage removal issues that pertain to Mr. Abualhayja and his business at 1165 Wyandotte Street West, and we have attached hereto as Exhibit "G" a true copy of photographs taken concerning the condition of the property for Ugarit Market. These images illustrate the improper disposal of cardboard and refuse on the premises, which has not been placed in an approved receptacle equipped with a secure lid to prevent access by rodents and other animals. Such waste disposal practices contravene the City's by-laws. Moreover, the ongoing littering attributable to Mr. Abualhayja's business has persisted despite multiple requests to cease these activities.

These facts should cause great concern for the neighbourhood. We respectfully assert that, given the Applicants' demonstrated disregard for established laws, they should not be granted the opportunity to continue engaging in unlawful activities. We kindly request that their application be denied on the grounds that it does not align with the public interest and that the Applicants do not exhibit the requisite good character to merit any benefits from the City.

AFFIDAVIT OF PATRICK JOHNSON

I, Patrick Johnson, of the City of Windsor, Province of Ontario, MAKE OATH AND SAY AS FOLLOWS:
1. I am a tenant at Wyandotte Street West. This is the property located at 1165 Wyandotte Street West. I have resided there since July 2021, but because of renovations to my apartment building, I now reside at human which is owned by Buu Quoc Tran, Where I have indicated that I have received facts from other sources, I believe those facts to be true.
2. I am familiar with the commercial tenants on the ground floor who operate Ugarit Market, which is a grocery store.
3. I am aware that the commercial tenants brought in a pallet of frozen chickens which they left outside overnight to thaw. They used a water hose to defrost the chickens. I witnessed rats and cats stealing chicken parts from the pallets. The next day, the tenants sold the remaining chickens at the store for human consumption.
4. Commercial trucks come to the property to load and unload goods during all hours of the night. These trucks cause damage by hitting the fence, utility poles, and air conditioning unit next to the building, on multiple occasions.
5. The property is constantly littered with garbage from their business and is piled up for days on end. Cardboard that was discarded outside the building at one point caused a fire. I called Windsor Fire and Rescue, and they put out the fire shortly thereafter. This garbage, including cardboard, plastic, and paper blows throughout the neighbourhood and alleys as it is not properly contained in approved garbage bins.
6. They take the garbage from their grocery store at 1165 Wyandotte Street West, and transfer it to the proposed site of the new grocery store located at 673 Wellington Avenue.
7. I am concerned that this behaviour will continue at the new site for the grocery store.
8. I am making this Affidavit in good faith for the purpose of providing information to the Standing Committee, and for no other or improper purpose.
