March 13, 2025 s. 36	Last day to withdraw nomination form before 2:00pm
March 16, 2025 s.35(2)	Nomination papers must be certified before 4:00pm on this date
March 16, 2025 s. 44(4) s. 65(4) 6	Proxy Certificate may be issued after 4:00pm on this date
March 17, 2025 s. 53	City Clerk declares emergency and postpones by-election due to COVID-19 pandemic.
August 12, 2025	City Clerk sets new by-election and advanced poll dates.
August 18, 2025 s. 44(4) s. 65(4) 6	Proxy Certificate may be issued starting this date – by appointment only.
September 7, 2025 s. 27(1)	City Clerk to provide interim list of changes to Voters' List to each candidate who received a copy of the Voters' List no later than this date.
September 7, 2025 s. 88.20(13)(b)	City Clerk to calculate final certificate of maximum campaign expenses and maximum amount for parties conducted after voting day to each candidate on or before this day.
Week of September 7, 2025	Election brochure to be mailed to all Ward 7 addresses by Canada Post
Week of September 14, 2025	Voter notification cards to be mailed by Canada Post to voters
September 29, 30 & October 1 & 3, 2025	Advance Voting – four days at WFCU Centre – Sports Gym
October 5, 2025	Voting Day at WFCU Centre only.

December 21, 2025 s. 88(30)	Deadline for filing financial statements is 2:00pm.
December 21, 2025	Deadline for candidates to apply to City Clerk for supplementary campaign reporting period
January 4, 2021 s.83(2)	Deadline for eligible elector to file application for controverted election with Superior Court of Justice
January 11, 2021 s. 83(3.1)	Deadline for applicant for controverted election to serve City Clerk with a copy of the application
January 20, 2021 s.83.23(9)	Deadline for candidates in default to apply for "late filing fee" of \$500 and submit financial statements
