<ul style="list-style-type: none"><li>• Notify Traffic Operations (<a href="mailto:tcp@citywindsor.ca">tcp@citywindsor.ca</a>) and all others checked below if <u>start date or end date / duration</u> changes.</li><li>• All Long Duration projects on major roads shall be to scale and have all distances labeled.</li><li>• Road closures on major roads will have posted detour tabs showing alternate routes.</li><li>• Road closures on a Truck Route will detour truck traffic along truck routes</li><li>• 3 meter minimum lane width to be maintained.</li><li>• All signs and spacing per Ontario Traffic Manual (OTM) Book 7 (2022)</li><li>• Should site conditions require a revision to attached plan, revise and resubmit traffic control plan.</li><li>• <b>DO NOT</b> place signs in pedestrian pathways, bike lanes or motorists sight lines.</li><li>• Any existing signs in Right of Way that conflict are to be covered so not to damage them. Do not remove City owned signs or poles.</li><li>• Temporary paint is not allowed unless pre-approved. Restore to original before leaving site.</li><li>• Changes or corrections to Traffic Control Plans, to be compliant with reviewed plans, are at the contractor's expense.</li><li>• Secure site per Ministry of Labour (MOL) requirements.</li><li>• Review of this drawing is for overall intent and traffic disruptions only.
