

## NOTICE OF PUBLIC INFORMATION CENTRE

### Tecumseh Road West Municipal Class Environmental Assessment Study

The City of Windsor has initiated an Environmental Assessment (EA) Study for the planning and preliminary design of transportation network improvements to Tecumseh Road West between Crawford Avenue and Janette Avenue. The proposed improvements will address the transportation needs of the corridor for a 20 year horizon, accommodate all road users, and address rail crossing requirements.

#### THE PROCESS

The Tecumseh Road West EA is being conducted as a Schedule 'C' project under the *Municipal Class Environmental Assessment (2007)*, as amended in 2015. The study will complete all necessary phases of the Municipal Class EA to receive environmental clearance for construction, namely:

- Establish the need and justification for the project
- Document existing environmental conditions
- Consider all alternatives
- Proactively involve the public and regulatory agencies in defining a recommended plan
- Meet the requirements of the Municipal Class EA.

#### PUBLIC CONSULTATION

The City wishes to ensure that anyone interested in this study has the opportunity to be involved and to provide input. A Public Information Centre is being held to provide information and receive feedback from the public and stakeholders. At this open house style meeting the City will present background information and the preliminary improvement alternatives, and receive public comments.
