Description:	<ul style="list-style-type: none"> <li>The new Canada Emergency Wage Subsidy (CEWS) provides a 75% wage subsidy to eligible employers for up to 24 weeks, retroactive to March 15, 2020.</li> </ul>	

	<ul style="list-style-type: none"> <li>• The CEWS prevents further job losses, encourages employers to re-hire workers previously laid off as a result of COVID-19, and help better position Canadian companies and other employers to more easily resume normal operations following the crisis.</li> </ul>
Special Conditions:	Any benefit received from the 10% temporary wage subsidy in a specific period generally reduces the amount available to be claimed under the CEWS in that same period. Please note that this Program is very prescriptive, so please refer to the Program Website for further details.
