OPA 79 has been initiated by the City of Windsor to develop an Urban Structure Plan as part of the City's Official Plan Review. The proposed policy changes aim to ensure the Official Plan identifies key structural

elements and the linkages between these elements to establish the strategic framework within which more detailed land use designations and polices can be established. OPA 79 applies City wide.
